TRUSTEES' REPORT HGBCHURCH – For the Financial Year 1 April 2024 to 31 March 2025

1. Vision Statement

At HGBCHURCH, we are committed to being **A Kingdom-Advancing Church**, rooted in Christ, fuelled by the Holy Spirit, and focused on eternity. Our mission is clear and compelling:

Every Life Transformed by God’s Kingdom. Every Community Impacted by His Love. Every Generation Empowered for Eternity.

2. Spiritual Reflection

This past year has been a testimony to the faithfulness of God and the power of vision aligned with Heaven. We have witnessed growth, transformation, and divine acceleration. As Jesus declared in Matthew 6:10, we have earnestly prayed and positioned ourselves to see His will done in our midst—and indeed, His Kingdom has come in fresh and tangible ways.

We stand amazed at what God has done and stirred by what lies ahead. We are not simply running programmes; we are building people. We have mobilised Kingdom life. We are not merely hosting events; we are hosting Heaven. We’ve seen the fingerprints of God on everything we have put our hands to, and our hearts burn with anticipation for all that lies ahead. HGBCHURCH continues to grow as a Spirit-led family, committed to making disciples, equipping saints, and reaching our community with the love and truth of Christ.

3. Objectives & Activities

At HGBCHURCH, our heartbeat is simple yet profound: to see every life transformed by God’s Kingdom, every community impacted by His love, and every generation empowered for eternity. Everything we do flows from this calling to promote the Christian faith in accordance with biblical principles, advancing education and charitable outreach both locally and globally.

This past year has been one of **growth, connection, and fresh opportunities to share Jesus**. Here’s how we have seen God at work among us:

- **Weekly Worship Gatherings:**

Every Sunday at 10:30 a.m., our church family gathers to encounter God together in vibrant worship and biblical teaching. Highlights included our Easter Sunrise Service, Christmas Day Worship, and the powerful New Year’s Eve Watch Night Service — moments where hearts were stirred, faith renewed, and lives touched. We have also continued to **livestream our services**, allowing those at home and further afield to join in real-time and remain connected to the life of the church.

- **Prayer & Fasting:**

January set the spiritual tone for the year as we devoted the entire month to prayer and fasting under the theme “Thy Will Be Done.” Life Groups, youth, and ministry teams led heartfelt prayer gatherings,

creating an atmosphere where God's presence was tangibly felt and spiritual momentum built for the months ahead.

- **Life Groups & Discipleship:**

Our Life Groups remain a vital part of our church life — meeting in homes and online for prayer, study, and mutual encouragement. These gatherings are more than meetings; they are where disciples are made, friendships are formed, and faith is nurtured.

- **Times of Refreshing Devotionals:**

In September 2024, we launched Times of Refreshing — our online weekly devotional series. This initiative has been a source of encouragement and spiritual renewal, helping individuals pause, reflect, and realign their hearts with God's purposes throughout the week.

- **Children & Youth Ministry:**

We remain passionate about raising a generation that loves and follows Jesus wholeheartedly.

- Kingdom Youth (11–16) and Kingdom Light (5–11) provided age-appropriate teaching and spiritual formation.
- Two Kingdom Kidz conferences — “Kingdom Keepers” in April and “Living For the King” in October — saw over 40 children and youth from church and community engage with God's Word in powerful and memorable ways.
- Our young people also attended Satellites, a national Christian youth festival, deepening their faith and forging strong friendships.
- Together with BCB Church, we launched a joint monthly youth gathering, uniting young believers for worship, the Word, and fellowship.

- **Community Outreach & Fellowship:**

Our mission to love our neighbours was beautifully expressed through our **Community Christmas Lunch**, where people from across the neighbourhood came to enjoy a warm festive meal and experience the love of Christ in a welcoming atmosphere. This simple act of hospitality reminded us that the Gospel is best seen when it is shared with both words and actions.

Through these ministries and moments, we have witnessed God's faithfulness and felt a renewed sense of purpose. Each gathering, outreach, and act of service has been another step towards becoming a **Kingdom-Advancing Church**, fulfilling the mission He has entrusted to us.

4. Community Engagement & Public Benefit

HGBCHURCH exists not just for its members, our ministries seek to serve the spiritual, emotional, and practical needs of the wider community. HGBCHURCH actively serves the public through:

- **Kingdom Tots Playgroup:** Offering a safe, welcoming space for young children and their carers every Monday.
- **Hall Hire to Community Groups:** Including hosting the Hither Green Ward Assembly by Lewisham Council and other civic engagements.
- **School Engagement:**
 - On 8 January and 22 January, HGBCHURCH members led assemblies and educational sessions for Brindishe School, engaging students with Christian faith and values.
- **Community Events:**
 - **Father's Day BBQ and Summer BBQ:** United families in celebration and outreach.
 - **Table Top Sales** (June & August): Fundraising for missions and a platform for local entrepreneurs.
 - **Pancake Day Fundraiser** (March): Raised over £265 for missions.

- **Share Jesus Community Lunch (March):** Provided free hot drinks and meals for the homeless and vulnerable with the love of Christ.

5. Achievements & Performance

- **Church Growth:** Five new members joined our church family, with increasing attendance across our weekly services and ministries.
- **Baptisms:** On 15 December, we hosted a joint baptism with Living Word Christian Fellowship, with five candidates publicly declaring their faith (three of the members were from Living Word Fellowship).
- **Child Dedications:** Three children were dedicated this year during joyful and heartfelt services.
- **Radiance Women's Ministry:**
 - Radiance Conference (October): Over 35 women attended an empowering day of teaching, worship, and fellowship.
 - **Mother's Day Dinner (March):** Celebrated the strength and legacy of mothers with over 45 in attendance.

Missions:

- Although **Mission Bulgaria 2024** was postponed due to flight costs, planning for 2025 is well underway.
- Our fundraising efforts have ensured we are financially and spiritually prepared for the year ahead.

6. Volunteers & Service

None of our progress would be possible without our faithful volunteers. Every event, meal, worship service, and outreach was carried by the selfless service of our members. In addition, many members actively serve in the wider community, bringing the light of Christ beyond the church walls.

7. Financial Overview

We give God thanks for His provision and the faithful generosity of our members and partners.

- **Total Income:** £174,416, primarily from tithes, offerings, and hall hire.
- **Total Expenditure:** £104,621, on ministry costs, missions, staffing, utilities, and events.
- **Reserves:** As of 31 March 2025, we hold reserves of £25,000 to ensure stability and future sustainability.

All financial planning and spending align with our commitment to good stewardship and Kingdom effectiveness.

8. Looking Ahead

Our hearts are full of expectation for the coming year. We believe God is positioning us for greater impact.

Key priorities include:

- **Mission South Africa** – In April 2025, we will partner with **Mighty Grace Church** in **Venda** to support evangelism, teaching, and community upliftment.
- **Mission Zambia** – Also in April, we will serve with the **Eva Chabala Foundation**, bringing hope and practical support to families and children.
- **Manse Purchase** – We are prayerfully working toward purchasing a church manse—an important step in establishing long-term stability and care for our pastoral leadership.
- **Radiance 2025** – Our women's conference will return next year, continuing to inspire and equip women to shine for the Kingdom.
- **Kingdom Kidz Conference (April 2025)** – Already in preparation to disciple the next generation in bold faith and joyful worship.

- **Mission Bulgaria 2025** – With resources in place, we will send a team to run a youth camp and youth discipleship.
- Strengthening our online ministry and digital outreach.

We are convinced that the best is yet to come. We are not just expanding property—we are enlarging our Kingdom influence. We are not just running a church—we are raising a generation. As we press forward, we do so with unwavering confidence, and HGBCHURCH has a vital part to play.

9. Conclusion

NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) FOR THE YEAR ENDED 31ST MARCH 2025

- These accounts have been prepared on a **Receipts and Payments** basis and in accordance with Section 133 Charities Act 2011.
- Managing / Administering the Charity represents direct expenditure incurred in the management of the church. Most of the management is carried out without charge by volunteers. This intangible cost is not included in the Statement of Financial Activities since there is no measurable cost to volunteers for their service.
- The Minister acts as one of the church's trustees and receives remuneration and other benefits in respect of his services as Minister, including the provision of manse accommodation rented by the church at a cost of £1200 per month.
- Office Equipment is not capitalised but expensed upon purchase.
- The custodian trustee of the church is the **Baptist Union Corporation Limited** which is a registered charity (number: 249635), and which is controlled by the Baptist Union Council. The church is also a member of the Baptist Union of Great Britain, and the London Baptist Association.
- The church pays pension contributions for its Minister to a Private fund (Standard Life), which is a defined contributions scheme and not contracted out of the State Second Pension. The church also pays pension contributions for its Administrator to Nest Pensions, which is also not contracted out of the State Second Pension.

Introduction

The trustees of HGBCHURCH are pleased to present this report for the financial period 23 June 2023 to 31 March 2024. Though HGBCHURCH registered in June 2023, active financial operations commenced in February 2024, following the transfer of assets. This brief period marks the beginning of a new chapter for our ministry, grounded in the mission to advance God's Kingdom, transform lives, impact communities, and empower every generation.

4. OBJECTIVES & ACTIVITIES

The primary objective of HGBCHURCH is to promote the Christian faith in alignment with biblical principles. In addition, the church seeks to advance education and engage in other charitable initiatives both within the UK and internationally. Key activities initiated since February include:

Worship Services

Weekly worship remains central, with services every Sunday at 10:30 a.m. Special seasonal services like our Easter Sunrise gathering have welcomed community participation, helping to spread the gospel locally.

Outreach and Evangelism

A pancake fundraiser for Mission Bulgaria on 13th February 2024, and our Easter Sunrise Service on 31st March 2024, have helped strengthen community connections. These initiatives encourage local engagement and support for global missions.

Youth and Children's Ministry

Programmes for young people include Kingdom Youth (ages 11-16) and Kingdom Light (ages 5-11), offering biblical teaching, fellowship, and community. Each group provides structured opportunities for growth, focusing on topics like prayer and the miracles of Jesus.

Life Groups and Discipleship

Life Groups meet regularly, offering small group fellowship, study, and worship. In March, all Life Groups gathered for a Lent study with themes centred around creation, fostering connection and spiritual growth.

Community Engagement

Our Kingdom Tots playgroup meets on Mondays, providing a supportive environment for young children and their carers.

5. ACHIEVEMENTS & PERFORMANCE

Our first two months have been encouraging, laying the foundation for Kingdom growth. Key highlights include:

Membership Growth

We welcomed new members as part of our commitment to making disciples.

Community Impact

Outreach events like the pancake fundraiser and Easter Sunrise Service have fostered community relationships.

6. FINANCIAL REVIEW

Financial operations for February and March reflect our emphasis on stewardship and transparency:

Income

Total income for this period was £29,978, primarily from tithes and offerings.

Expenditure

Total expenditure was £15,703, directed towards foundational church expenses.

Reserves

The church holds reserves of £25,000 as of March 31st, in line with policy to ensure future sustainability.

7. GOVERNANCE & STRUCTURE

HGBCHURCH is governed by a board of trustees responsible for overseeing the strategic direction, financial management, and legal obligations of the church.

We trust that God will faithfully guide us as we continue advancing His Kingdom both within our community and beyond.

We're eagerly anticipating the Kingdom Kidz Conference in April, an exciting opportunity to sow into the lives of our children. Additionally, we look forward to taking our Kingdom Youth to Satellites, a time of fellowship, growth, and spiritual renewal. And of course, we are thrilled to celebrate our fathers together at the upcoming Father's Day BBQ!

9. CONCLUSION

The trustees express sincere gratitude to all staff, volunteers, and members for their faithfulness and dedication. We look forward to witnessing God's work in and through HGBCHURCH in the coming year.

Basis of independent examiner's statement



1. These accounts have been prepared on a **Receipts and Payments** basis and in accordance with Section 133 Charities Act 2011.
2. Managing / Administering the Charity represents direct expenditure incurred in the management of the church. Most of the management is carried out without charge by volunteers. This intangible cost is not included in the Statement of Financial Activities since there is no measurable cost to volunteers for their service.
3. The Minister acts as one of the church's trustees and receives remuneration and other benefits in respect of his services as Minister, including the provision of manse accommodation rented by the church at a cost of £1200 per month.
4. Office Equipment is not capitalised but expensed upon purchase.
5. The custodian trustee of the church is the **Baptist Union Corporation Limited** which is a registered charity (number: 249635), and which is controlled by the Baptist Union Council. The church is also a member of the Baptist Union of Great Britain, and the London Baptist Association.
6. The church pays pension contributions for its Minister to a Private fund (Standard Life), which is a defined contributions scheme and not contracted out of the State Second Pension. The church also pays pension contributions for its Administrator to Nest Pensions, which is also not contracted out of the State Second Pension.
