Executive Summary

Restored To Ignite Ministry, a UK-registered charity, presents its inaugural financial statements and trustees annual report for the period ending 27 April 2024. With no financial transactions recorded during this foundational phase, the trustees have prioritized establishing governance frameworks aligned with the Charity Commission's requirements and the charity's mission to reduce youth crime and knife violence while supporting women affected by domestic violence through education and community programs. This report adheres to the Charities Statement of Recommended Practice and demonstrates compliance with regulatory obligations for entities at the nil income threshold.

2. Domestic Violence Support: Providing holistic assistance to women affected by domestic abuse, including counseling, legal advocacy, and crisis intervention.

Trustees have implemented a governance framework ensuring all activities align with these objectives.

2. Women's Support Services: Collaboration with domestic abuse shelters to provide trauma informed counseling and employment assistance.

Risk Management

Identified Risks:

- Safeguarding vulnerabilities among youth and domestic violence survivors.
- Reputational risks associated with sensitive client data.

Mitigation Strategies:

- Enhanced background checks for future staff and volunteers.
- Secure digital systems for case management, compliant with UK data protection laws.

Reserves Policy

The board has adopted a reserves policy targeting six months of operating costs once programs commence, ensuring continuity during funding gaps.

Regulatory Compliance

Charity Commission Obligations:

- Annual Return to be filed within ten months of the financial year end.
- Financial statements will be publicly accessible via the Charity Commission's register, excluding personal trustee data.

Tax Compliance:

- No Corporation Tax obligations.

- Gift Aid registration deferred until donor income materializes.

Future Operational Strategy

Quarter two 2024:

- Needs assessment in Croydon and Mitcham high risk neighborhoods.
- Recruitment of qualified counselors and youth workers.

Quarter three 2024:

- Pilot mentorship program for at risk youth aged 14 to 18.
- Partnership with domestic abuse organizations to design outreach programs.

Grant Applications: Targeting the National Lottery Community Fund and Violence Reduction Units.

Community Campaigns: Crowdfunding initiatives aligned with anti violence and domestic abuse awareness.
