Activities: The Charity is focused on delivering a Pump Track for Histon and Impington and raises funds for all phases of the project. It is working with Stakeholders to develop land-use plans so a site can be found and developed to allow all ages groups and users a Pump track that will cater for all. We are also working with long-term developers for other sites.
