Wednesday evening the ministry and media team meet to practice and discuss the mission for the following Sunday Thursday at 10 am is open to children from birth to school age and finishes at 12 noon. Grace Kids and the youth attend on Friday evenings.

Saturday morning is for intense prayer. Once per month the Ladies of Grace meet. On another day the Men meet for breakfast and delve into the bible. Often guest speakers are invited. Throughout the church year on occasion there are guest speakers or special musicians.







How the charity operates

Each year there is a vision statement from the Senior Pastor. The structure and management of the church are based around that vision. Jesus Christ is the Head of our church.

The Ministry team is generally headed by the Head Minister supported by other Ministers. The Head Minister at the start of this period was Jamie Boulton who subsequently resigned. The Assistant Minister, Mr Omatsuli Onuwaje took over the leadership until the AGM. Pastor Omar Onuwaje applied for the position of Senior Pastor on an Honorary basis and was unanimously voted in at the AGM. Pastor Omar brought his vision statement to the members of the church and is active in bringing his vision to life. Pastor Omar leads the church with the assistance of four other members who complete the Ministry team. The worship/music group come under the Ministry team. There are several volunteers in the church who have been split into groups such as cleaning and admin etc., these groups have a team leader, and it is the team leader's job to liaise with the group and bring a report to the Board Meeting and to request whatever funds may be required.

Recruiting of Trustees comes about as and when one is required. They are taken from the Church membership. We advertise internally for Trustees if none have come forward voluntarily.

Objects of the Church

The charitable objects that Grace Pentecostal work under is outlined below:

1. To advance the Christian faith in accordance with the Constitution – the Church's governing document – in such ways and such parts of the UK and the world.
2. To relieve sickness and financial hardship and to promote and preserve good health by the provisions of funds, goods and services of any kind including through the provision of counselling and support in such part of the UK or the world as the church leaders think fit.

Activities

Activities of the church are outlined in the Constitution and include activities both face to face and online. Online is reaching out to a wider audience.

Face to face activities start with the Sunday morning service which includes communion and also a period of teaching. Whilst this teaching is taking place the children of the church leave the hall to have their Sunday School. For the younger children there is a creche which includes many games to keep them occupied. This service is also streamed online. Sunday evening is a session set out as a café church and is for intense and thorough Bible Study. The music group meet to practice during the week on a Wednesday and the Ministry teams meet to discuss the forthcoming ministerial teachings.

Thursday evenings is an open invitation for people to join the Celebrate Recovery Group who deal with hurts, habits, hang-ups, addictions or if people find life unmanageable or out of control. They meet weekly in small confidential groups. Thursday morning sees the arrival of around 20-30 toddlers who come for soft play, games, food, and a meeting place for parents. Some of the parents belong to the church membership and some do not – all are welcome.

Friday evenings is the childrens' youth clubs.

Saturday once a month is a Men's breakfast which is arranged by one of the Ministry team and often has a speaker from elsewhere. The attendees have a free fully cooked breakfast. The other Saturday mornings are a special prayer time.

Ladies of Grace meet for ladies only. They share some food, have a chat, and often have a guest speaker and games. They meet once a month on a Saturday.

One Man-One Soul are a group of church members who pray at church then go into the town centre to speak to as many people as possible about the name of Jesus and invite them to the church.

The achievements of the church and the performance are shown in the number of people who attend the church, and each activity is successful. The activities are run by volunteers of the church who also have a Head of Department and reports are put in at each board meeting. As to public benefit, the church is open for all the public who wish to attend. It is advertised online and within church and we try to offer a variety for most people.

Financial Review

The church is in a healthy position paying any debts almost immediately and budgeting for any upcoming expenditure. At the year end cash reserves amounted to £50,630 – an increase of £26,542, primarily as a result of a legacy of £30,000.

Reserves Policy Statement

The church maintains reserves to ensure financial stability and continuity of charitable activities. Our target reserve level is £10,500, based on three months expenditure. The church holds reserves within our savings account currently £30,000 for Church Planting and future building needs including construction,

renovations and essential maintenance. These reserves will be reviewed regularly to ensure they align with the church strategic objectives.

Legal

On 26th June 2023 the CIO was registered and all matters have now been completed other than moving the church buildings to the CIO. Once this has been completed the original charity will be closed down.

Risk management

The trustees actively monitor the various risks that face the church – property, staffing, reputational. A robust safeguarding process is in place.
