

FOWLC CIC was set up to operate Wadebridge Sports centre as part of a campaign to stop the closure of the facilities. Funding agreements were agreed and grants secured from Cornwall Council for both capital and revenue expenditure. Following the set up of the CIC, the directors continued to monitor the operational success of the CIC and possible ways to reduce overheads. As CIC's are not charitable entities, they are not eligible for business rates relief and due to this this discussions were undertaken as to the potential for a CIO to be set up to hold the lease of the sports centre with the CIC maintaining control of the operation management of the sporting facilities. The Friends of Wadebridge Sports & Leisure Centre CIO was duly registered with the Charities Commission on 27 June 2023 to facilitate this structural change. On registration of the CIO, all grant funding from Cornwall Council was transferred from the CIC to the CIO on agreement of Cornwall Council. Following the transfer of grant funding to the CIO, the CIO will now as part of its charitable objectives provide grant funding to the CIC to assist with ongoing improvement of the sports centres facilities.
