



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life or, if held under a finance lease, over the lease term, whichever is the shorter.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Hire purchase and leasing commitments

Assets obtained under hire purchase contracts or finance leases are capitalised in the Balance Sheet. Those held under hire purchase contracts are depreciated over their estimated useful lives. Those held under finance leases are depreciated over their estimated useful lives or the lease term, whichever is shorter.

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the period of the lease.

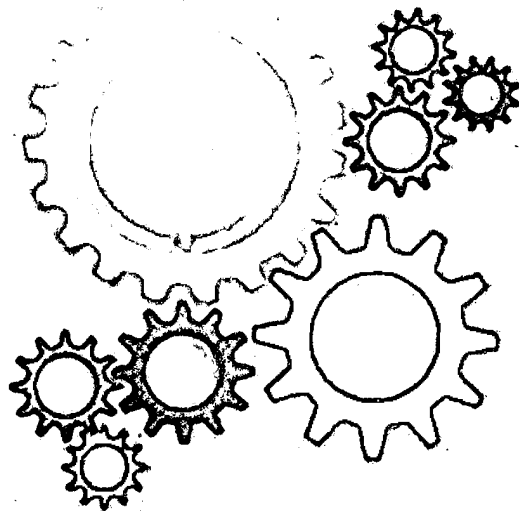

Our aims and objectives

Our charity's objects are specifically restricted to the following:

- a. The relief of unemployment for the public benefit in such ways as may be thought fit including assistance to find employment by providing training and courses in employability skills such as time keeping, following instructions, CV building, team working, communication skills and interview techniques.
- b. To advance education and training among unemployed people or people who are not in education, employment, or training (NEET) in North Yorkshire by providing mentoring and courses in life and functional skills and vocational training to improve their employment opportunities.

Our activities in the year that deliver public benefit

Home educated continued

A dedicated provision was piloted and is now a long term provision due to its success, it is aimed at year 10 and year 11 school students who are not attending mainstream school and have been signed off school role as elected home educated. We have over 40 young people on board with another 30 on the waiting list. This focuses on getting young people who have been isolated and not getting any education back into a structured provision that works on increasing confidence, life skills and educational attainment with functional skills maths & English. This project started in June 2024 and so far we have seen over 40 young people attend, 13 complete and progress back into mainstream education and over 90% have achieved at least one qualification in maths or English.

Youth Development

A holistic provision aimed at young people aged 16 to 19 years who have struggled with mainstream education, have poor mental health and need support to move forward with further education or employment. This provision provides varied support with small group work and one to one all with the aim of increasing skills and opportunities. Young people engage in sessions focused on a variety of skills such as educational, life skills and confidence building. Sessions include functional skills, art sessions, visits to the gym for mental health and fitness as well as workshop sessions. This year we have seen over 60 young people access this provision, with results this year showing 62% of young people engaged have progressed onto either further education or employment, with 80% achieving at least one qualification.

Furniture Works

The workshop continues to support local people build skills and confidence in a practical way. Utilising donated furniture destined for land fill, clients engage with repairing or reusing each piece of furniture with the intention of selling within our retail unit. This year we have seen sessions for women only adults and young people with over 60 people accessing the workshop and gaining skills and confidence, our busiest yet. The workshop has been successful in building skills that clients can take with them into their own home lives and continue to use in the future. As part of this project, the furniture shop is also an opportunity for clients to gain

experience in retail and build customer service skills. It is also an opportunity to see the furniture that is worked on sold onto someone who will treasure it. This is an amazing way of building confidence and self esteem, having a piece of furniture that has been worked on by a client not only wanted by someone but paid for. Clients are proud that their work is appreciated but also that the profits made are reinvested back into the organisation to help support more people.

Rise 2 Thrive/Trailblazer

Working in partnership with Better Connect and the York & North Yorkshire combined authority, enables us to work with economically inactive adults as well as adults in work who are neuro divergent and need extra support. Split into two parts Rise2Thrive and Trailblazer, for adults and young people respectively, our targets for the Rise to Thrive part of this programme are 33 clients reached and engaged and we have achieved this before the contract end. Trailblazer was a smaller profile of 15 with 11 so far achieved.

Principal Funding Sources

With the exception of a small income, generated from our retail unit, our principal funding is generated from grants and contracts. Current main grants are received from the National Lottery Community Fund and Children in Need with smaller grants and contracts received from the combined authority and national grant funders. The focus for future funding is core funding to ensure services continue to grow and develop without the need for reinvention of new projects.

Reserves

The trustees have agreed that a minimum of 3 months reserves need to be maintained and these are at present over 3 months. Trustees are aware that reserves are being utilised to fill shortfalls in staff funding until new grants can be sourced.

Structure, Governance & Management

The organisation is a registered charitable company, registered as such on the 9th July 2023. The organisation was originally founded in March 2011 as a community interest company by founders Michelle Padron-Kitching and Sarah Thornton. Upon the conversion of the charity, both Michelle and Sarah were designated as Chief Executive Officers of the charity.

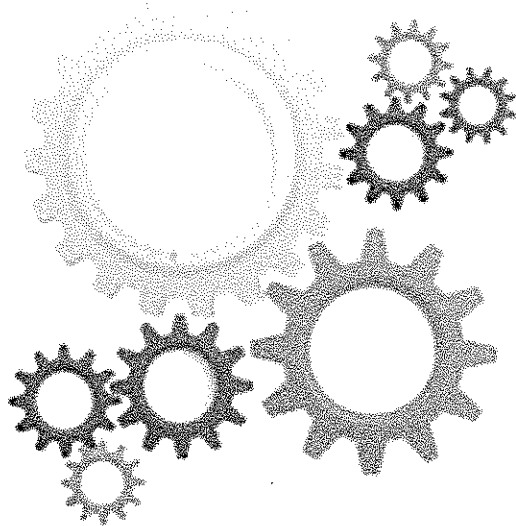

Our aims and objectives

Our charity's objects are specifically restricted to the following:

- a. The relief of unemployment for the public benefit in such ways as may be thought fit including assistance to find employment by providing training and courses in employability skills such as time keeping, following instructions, CV building, team working, communication skills and interview techniques.
- b. To advance education and training among unemployed people or people who are not in education, employment, or training (NEET) in North Yorkshire by providing mentoring and courses in life and functional skills and vocational training to improve their employment opportunities.

Our activities in the year that deliver public benefit

Home educated

A dedicated provision aimed at year 10 and year 11 school students who are not attending mainstream school and have been signed off school role as elected home educated. At present this is supporting 12 young people with a further 21 on the waiting list. This focuses on getting young people who have been isolated and not getting any education back into a structured provision that works on increasing confidence, life skills and educational attainment with functional skills maths & English. This project started in June 2024 and as such is too early to report statistics other than those attending.

Youth Development

A holistic provision aimed at young people aged 16 to 19 years who have struggled with mainstream education, have poor mental health and need support to move forward with further education or employment. This provision provides varied support with small group work and one to one all with the aim of increasing skills and opportunities. Young people engage in sessions focused on a variety of skills such as educational, life skills and confidence building. Sessions include functional skills, art sessions, visits to the gym for mental health and fitness as well as workshop sessions. This year we have seen 46 young people access our provision, with a further 5 to start shortly. Results this year show 42% of young people engaged have progressed onto either further education or employment, 15% withdrawn due to severe anxieties or pregnancy and the remaining 43% still actively engaged and working towards progressions.

Furniture Works

The workshop continues to support local people build skills and confidence in a practical way. Utilising donated furniture destined for land fill, clients engage with repairing or reusing each piece of furniture with the intention of selling within our retail unit. This year we have seen sessions for women only adults and young people with 38 people accessing the workshop and gaining skills and confidence. The workshop has been successful in building skills that clients

can take with them into their own home lives and continue to use in the future. As part of this project, the furniture shop is also an opportunity for clients to gain experience in retail and build customer service skills. It is also an opportunity to see the furniture that is worked on sold onto someone who will treasure it. This is an amazing way of building confidence and self esteem, having a piece of furniture that has been worked on by a client not only wanted by someone but paid for. Clients are proud that their work is appreciated but also that the profits made are reinvested back into the organisation to help support more people.

Rise 2 Thrive

Working in partnership with Better Connect and the local authority, this UKSPF programme enables us to work with economically inactive adults as well as adults in work who are neuro divergent and need extra support. Our targets for this programme are 28 clients reached and engaged and so far 22 have been engaged and 5 have achieved their goals with a further 6 months to go.

Current main grants are received from the National Lottery Community Fund and Children in Need with smaller grants and contracts received from the local authority (UKSPF) and national grant funders. 
