**Structure, governance and management**

**Governing document**

The unincorporated Trust was established by a Trust Deed dated 19 April 2023 and registered as charity with the Charity Commission on 11 July 2023.

**The aims and objects of the Trust**

The Trust is established for the promotion, support and advancement of charitable purposes of all kinds and in particular the advancement of education and the preservation and protection of good health for the public benefit

**Appointment, induction and training of Trustees**

The Trustees listed above have served in office during the period ended 31 March 2024. Future Trustees are appointed by resolution of the Trustees and are briefed on their legal obligations under Charity Law. Trustees are encouraged to attend appropriate external training events where these will facilitate the undertaking of their role.

**Risk management**

The Trustees have assessed the major risks to which the Trust is exposed, in particular those related to operations and finances of the Trust and are satisfied that systems are in place to mitigate exposure to the major risks.

**Public benefit**

The Trustees confirm that, in exercising their powers and duties, they have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission.

**Achievements and performance**

**Review of activities**

The Trust was founded by a generous donation of £25,000 made by a Trustee. The main activity of the Trust is the review of potential grant applications and to consider which to support by reference to the Trust's Grant Making Policy document. To date the Trust has not received any suitable projects to support but are confident that the Trustees will be in a position to award grants to eligible applicants over the coming years.

At 31 March 2024 the Trust held bank and cash balances of £28,698.70. These unrestricted funds are held in order to maintain the activities of the Trust.
