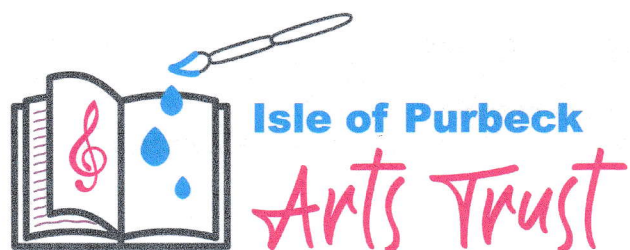

The trustees present their report for the year ended 30 June 2025.

Objects

The Isle of Purbeck Arts Trust exists for the public benefit to promote the education of people [particularly, but not exclusively, under the age of 25 years] in all forms of the arts in the Isle of Purbeck and surrounding area in such ways as the charity trustees think fit, including by:

1. Awarding to such persons grants or scholarships to further their education in the arts;
2. Advancing the education of young persons at schools by making grants to assist;
3. Assisting any charitable organisations with similar charitable objects.

Main Activities

The main activity of the trust is the award of bursaries and grants to young people in pursuance of the trust's objects and grant making policy, both individually and in a school setting, and assisting local charitable organisations.

Public Benefit Disclosure

We confirm that the Trustees have had regard to the guidance issued by the Charity Commission on public benefit, in deciding on the activities of the CIO.

Grant making policy

We can only fund projects and activities that are exclusively charitable and fall within the objects of the charity. The charity will consider all applications that fall within our charitable purposes and meet our funding criteria and, for which, the due diligence process has not identified any unacceptable issues.

The charity does not usually set any limits on the amount of funding that may be made available, but please note that our funding is limited and, inevitably, we are able to only make small grants. In exceptional circumstances, we may make repeat grants. Grants will be made based on the funding available and solely on merit.

Activities' Report:

This year the Isle of Purbeck Arts Trust has received applications for support from all 3 of its funds.

Emmie & Rex Neate Bursary Fund

This fund was set up by Rex Neate in memory of his wife Emmie, and keen member of the Purbeck Flower Club. The fund makes awards mainly but not exclusively to young people taking further education courses in the arts.

Eight candidates applied for a Bursary in September. The applicants included a student in their final year of studying model making seeking funds to help with participating in a major industry exhibition, an art graduate setting up their own studio, a violinist in their final year on the BMus course at the Royal College of Music, and three students beginning degree courses: i) BMus at Southampton University ii) Jazz Piano BMus at Trinity Laban Conservatoire and iii) Musical Theatre at Brighton Academy. Also, a ballet dancer who needed funds for travel, pointe shoes and other

necessary accessories to take part in short term contracts and a drummer seeking funds to buy an electric drum kit.

All received excellent references and £2,400 was allocated to the first 6 applicants. More money was available in January 2024, when a further application was received for a student seeking funding to attend a short course in theatre directing at the Royal Central School of Speech & Drama over the summer. This student and the ballet dancer and drummer were each awarded £300 and a further £1,200 was allocated to the six candidates who received awards at the start of the academic year.

The Isle of Purbeck Flower Club received £1,572 as the due share of interest received on this investment, as stipulated in the legacy from Rex Neate.

Douglas Strickland Bursary Fund

This fund was established to help support the arts in local schools with money to purchase items that would be of lasting use to the school.

A total of 10 schools were contacted about being eligible to apply for a Bursary this academic year and 8 submitted applications. These included requests to buy a diverse range of items, including outdoor musical instruments, a class pack of percussion instruments, cooking equipment, clay tools and clay, a P.A. System, 4 table top desk mounts for cameras, paint for repainting art and games on a primary school playground and clothes hanging rails for the Dance School. A total of £2,213 was awarded to these schools.

Community Trust

Two applications have been received this year, one seeking funding to pay for a professional artist to visit a Primary School and work with children as part of the Purbeck Young Artists programme and another to fund a composer to work with a local writer to develop creative workshops and performances based on her latest book for young children. £250 was awarded to each project.

Financial Results for the Year

Grants and awards amounting to £8,785 (2024 - £7,900) have been made in accordance with our grant making policy and the Trust ends the year with free reserves of £4,277 (2024 - £4,237), designated reserves of £1,668 (2024 - £2,168) and restricted reserves of £253,131 (2024 - £253,730).

Reserves Policy

It is the policy of the trustees to maintain adequate reserves to enable the charity to offer as many grants and awards as possible from the income generated by the investments. The level of cash reserves is monitored and reviewed annually by the Trustees. Free cash reserves at the end of the year amounted to £4,277 (2024 - £4,237). The trustees are satisfied with the outcome of this year but they continue to monitor the performance of the investments and are continually looking at alternative means of funding.

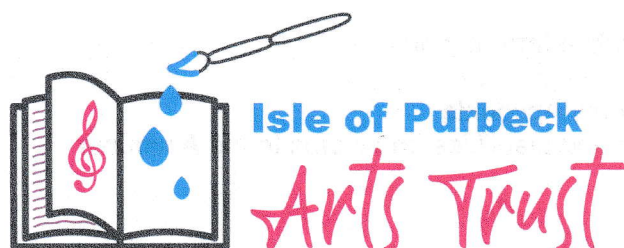

Emmie & Rex Neate Bursary Fund

This fund was set up by Rex Neate in memory of his wife Emmie, and keen member of the Purbeck Flower Club. The fund makes awards mainly but not exclusively to young people taking further education courses in the arts.

Five candidates applied for a Bursary in September and four Awards were made with one being held over until January. The applicants need were wide ranging; a recent Oxford English graduate whose play had been accepted for the Edinburgh Fringe Festival needed financial assistance to secure a venue and to film an extract of the play combining hi-tec puppetry and live performance; a young ballet dancer had been

offered a part in Swan Lake with a professional company in Cork, but needed funds for travel, pointe shoes and other necessary accessories; a final year Art & Writing student at UWE needed funds in order to reduce the hours he would need to work to finance his final year; an Fine Art graduate from Goldsmiths University of London wanted funds for a 3-month Intensive Drawing Course delivered by the Royal Drawing School and a talented drummer in Year 13 was seeking funds to buy an electric drum kit which he could take to university next year.

All received excellent references and £3,000 was allocated between the first 4 applicants. More money was available in January 2024, when a total of £1,200 was allocated to the dancer for help with the costs of attending the Acosta Advanced Training Hub for a 6-month Pre-Professional Course, to the final year UWE student and to the young drummer.

The Isle of Purbeck Flower Club received £1,000 as the due share of interest received on this investment, as stipulated in the legacy from Rex Neate.

Douglas Strickland Bursary Fund

This fund was established to help support the arts in local schools with money to purchase items that would be of lasting use to the school.

A total of 10 schools were contacted about being eligible to apply for a Bursary this academic year. One school didn't apply, one applied after the closing date and the remaining 8 schools applied for funds to buy a diverse range of items, including building an outdoor performance area, a set of 10 Djembe drums, a good quality microphone, kiln shelves and tiles, an outdoor frame for suspending musical instruments in a sensory garden, costumes for a dance show and Mighty Writer, an innovative classroom aid to writing mainly for KS1 children. A total of £2,300 was awarded to these schools.

Community Trust

Only one application has been received this year, seeking funding to pay for a professional artist to visit a Primary School and work with children as part of the Purbeck Young Artists programme. This programme, which is part of Purbeck Art Weeks, sends artists into Primary schools all over Purbeck to work with the students in many different media – paint, clay, glass, masks, model making, banner printing, screen printing, textiles and so on. £400 was awarded.

Financial Results for the Period

During the period since registration with the Charity Commission, the relevant free reserves and restricted bursary funds (cash and investments) have been successfully transferred from the Isle of Purbeck Arts Club to the Trust. Grants and awards amounting to £7,900 have been made in accordance with our grant making policy and the Trust ends the period with free reserves of £4,237, designated reserves of £2,168 and restricted reserves of £253,730.
