New trustees are appointed by a resolution passed at a meeting of the charity trustees.

The focus of the Foundation for the year has been aimed at the promotion of good health and relief of sickness, and relief of need for the public benefit.

Achievements and performance

The trustees consider that they have achieved their targets for the year.

Financial review

The trustees hold cash of £152,239 at the balance sheet date, for the furtherance of charitable causes.

Policy on reserves

All donations made to the Foundation have been made free from any restriction in terms of the use of the funds. Under the terms of the constitution, the income and property of the Foundation must be applied solely towards the furtherance of the Foundation's objectives. Consequently, the entire fund is considered to be unrestricted. The trustees' approach to supporting charitable causes is that donations are made on a discretionary basis, and as such, the trustees do not consider it necessary to have a policy regarding reserves. The trustees may exercise the powers of the Foundation, namely to borrow money, acquire or dispose of any property, and invest funds as required.
