PROMOTING EDUCATIONAL, SOCIAL AND RECREATIONAL EVENTS INVOLVING THE LOCAL COMMUNITY. 4. BUILDING PEOPLE'S KNOWLEDGE AND CONFIDENCE IN THEIR OWN CULTURAL HERITAGE AND ITS POTENTIAL CONTRIBUTION TO A MULTI-CULTURAL SOCIETY
