Trustees' Report

The trustees, who are directors for the purposes of company law, present the annual report together with the financial statements of the charitable company for the year ended 30 November 2024.

Objectives and activities

Objects and aims

Mandem Meetup promotes and protects the mental health of men experiencing challenges that negatively impact their well-being. By offering psycho-social interventions, support, guidance, and practical advice, the charity removes stigma around men's mental health through fostering brotherhood and community. The Advancement Of Health Or Saving Of Lives.

Objectives, strategies and activities

Mandem Meetup provides free activities that reduce isolation and empower men to improve their physical and mental well-being:

- Mandem Outdoors: Big hikes, local walks, bushcraft, and wild camping.
- Mandem Train: Football, calisthenics, WorkIN/WorkOUT, gym sessions, Hyrox, yoga, indoor rock climbing, bike riding, Brazilian Jiu-Jitsu.
- Mandem Learn: Tension and Trauma Release Exercises, Meditation, chess club, photography, poetry, workshops
- Mandem Help: Outreach (clothes and essentials for those in need), community tidy-ups, free community events.
- Mandem Talk: Talking Circles across nine locations in Manchester and Wolverhampton.
- Prison Work: Supporting Outspoken staff at We Are Survivors to ensure clients on their waiting list for Trauma therapy received peer support and more.

Mandem Outdoors

Funded by Sport England

Attendees 620 - New faces 127

Over the 12 months we took the men to 12 different locations around the UK including the main national parks and all 3 of the highest peaks - Snowdon, Scafell Pike and Ben Nevis.

We united two cities to create one big group of Mandem allowing men to feel connected to an even bigger community and find togetherness across different cities.

The men in Wolverhampton hiked up The Wrekin Forest 12 times and created an outdoor seating space to conduct Talking Circles, eat food together and have a controlled fire.

The men of Manchester got to explore all the beautiful green spaces in Greater Manchester utilising routes created by GM Ringway initiative.

Outcomes:

- Feelings of connectedness to the land and to other people
- Reduce stress and anxiety
- Reduced depression
- Increased confidence to go into green spaces
- Improved physical activity levels

Mandem Train and Mandem Learn

Attendees 1823 - New faces 502

Mandem Train gave men the opportunity to come together to push through glass ceilings, improve physical and mental resilience through exercise. Mandem Learn gave men the opportunity to share skills, develop new ways to regulate their nervous systems and become more employable. We introduced men to different activities so they could try new things that they normally wouldn't have access to through financial barriers, lack of people to do it with or lack of knowledge.

Providing clothing, toiletries and footwear for people who are financially insecure, are homeless or at risk of being homeless. We recruited men from the community to volunteer to give out these much-needed amenities. That meant that the lads who helped felt like they were giving back, had purpose and felt like they belonged.

Our Talking Circles offer a safe, peer led environment to offload things that are on the minds of our men without judgement or expectation. It's a trauma informed space held by trained facilitators who are safeguard trained and DBS checked. A container is set out lining the rules of engagement including no interruptions or unsolicited advice and 5 questions are asked - How are you feeling: physically, emotionally, relationally, spiritually and what are you grateful for?

Prison Work

Report from OutSpoken Director for Through the gate Service with We Are Survivors:

"2 Mandem staff that covered 6 prisons across the North West of England provided 816 sessions. 15 clients have transitioned into to the WAS Community services, after having some type of session with Mandem staff within the prison estates.

We can see the impact above that the Mandem partnership had on clients, but also it must be mentioned the great support that the Mandem Meet up gave to OS staff. They provided a great help with assessments, waitlist check-ins, face to face interventions and through the gate support in prisons that have high demand and waiting times for therapy. This took pressures off staff, so they were able to do their roles as therapists and see more clients.

The interventions that Mandem provided added huge value to the client's experience whilst waiting for therapy in custody, along with invaluable through the gate support, pick up on release and further community support.

We would like to thank Mandem for all the care and dedication they provided to the men they worked with, their collaborate approach with clients and staff alongside the trust they built with some of the most vulnerable men within the prisons estate who had given up hope was humbling to see.

Your kindness and determination are immeasurable and will be remembered by many of those whom' lives you have touched."

How the Charity's Work Provided a Public Benefit

Mandem Meetup addresses critical mental health and well-being challenges among men, particularly those who are marginalised or underrepresented. Activities such as Talking Circles, hiking, and creative workshops foster resilience, reduce isolation, and improve mental and physical health. For example, the Through the Gate program in prisons offers opportunities for men to transition from custody to community aiding rehabilitation and reducing recidivism.

Compliance with the Public Benefit Requirement

Structure, governance and management

Risk Management

The Risk Governance Trustees reports to Board as a standing agenda item and the Chief Executive Office presents an overview of any changes within the Risk Register.

In addition to this, a full annual review of risk is carried out by officers of the Board.

The Treasurer, Chief Executive Officer also meet, as part of Financial Risk Management and Governance, to review accounts, cross check cash flow, and identify any issues on the horizon. The sub groups are then reported back to the board at each board meeting.

Key risks include lack of experienced Trustees, financial sustainability, safeguarding, and operational challenges. These are mitigated through robust policies, regular reviews, and trustee oversight.

Challenges Faced

Increasing demand for services required creative approaches to maximise impact while operating within budget constraints, also highlights need for more transport options.

Plans for the Future

Projects Planned for the Upcoming Year

- Launching new Talking Circles in Tameside, Trafford (addiction-specific), and Gorton.
- A two-year contract starting January 2025 for Through the Gate services in Northwest prisons.
- Continued prison work in the Midlands.

Growth Goals

- Target annual income of £250,000.

Financial instruments

Objectives and policies

The charity's activities expose it to a number of financial risks including credit risk, cash flow risk and liquidity risk. The use of financial derivatives is governed by the charity's policies approved by the board of trustees, which provide written principles on the use of financial derivatives to manage these risks. The charity does not use derivative financial instruments for speculative purposes.

Cash flow risk

The charity's activities expose it primarily to the financial risks of changes interest rates. Interest bearing assets and liabilities are held at fixed rate to ensure certainty of cash flows.

Credit risk

The charity's principal financial assets are bank balances and cash, trade and other receivables, and investments. The charity's credit risk is primarily attributable to its trade receivables. The amounts presented in the balance sheet are net of allowances for doubtful receivables. An allowance for impairment is made where there is an identified loss event which, based on previous experience, is evidence of a reduction in the recoverability of the cash flows.

The credit risk on liquid funds and derivative financial instruments is limited because the counterparties are banks with high credit-ratings assigned by international credit-rating agencies.

The charity has no significant concentration of credit risk, with exposure spread over a large number of counterparties and customers.

Liquidity risk

In order to maintain liquidity to ensure that sufficient funds are available for ongoing operations and future developments, the charity uses a mixture of long-term and short-term debt finance.

Further details regarding liquidity risk can be found in the Statement of accounting policies in the financial statements.

Statement of trustees' responsibilities

The trustees (who are also the directors of Mandem Meetup for the purposes of company law) are responsible for preparing the trustees' report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland".

Company law requires the trustees to prepare financial statements for each financial year. Under company law the trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including its income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards, comprising FRS 102 have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping proper accounting records that can disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website. Legislation governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

Disclosure of information to auditor

Each trustee has taken steps that they ought to have taken as a trustee in order to make themselves aware of any relevant audit information and to establish that the charity's auditor is aware of that information. The trustees confirm that there is no relevant information that they know of and of which they know the auditor is unaware.



1 Charity status

The charity is limited by guarantee, incorporated in England & Wales, and consequently does not have share capital. Each of the trustees is liable to contribute an amount not exceeding £1 towards the assets of the charity in the event of liquidation.

2 Accounting policies

Summary of significant accounting policies and key accounting estimates

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Statement of compliance

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice (applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)) (issued in October 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Basis of preparation

Mandem Meetup meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

Going concern

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern nor any significant areas of uncertainty that affect the carrying value of assets held by the charity.

Income and endowments

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of the income receivable can be measured reliably.

Donations and legacies

Donations are recognised when the charity has been notified in writing of both the amount and settlement date. In the event that a donation is subject to conditions that require a level of performance by the charity before the charity is entitled to the funds, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the charity and it is probable that these conditions will be fulfilled in the reporting period.

Grants receivable

Grants are recognised when the charity has an entitlement to the funds and any conditions linked to the grants have been met. Where performance conditions are attached to the grant and are yet to be met, the income is recognised as a liability and included on the balance sheet as deferred income to be released.

Expenditure

All expenditure is recognised once there is a legal or constructive obligation to that expenditure, it is probable settlement is required and the amount can be measured reliably. All costs are allocated to the applicable expenditure heading that aggregate similar costs to that category. Where costs cannot be directly attributed to particular headings they have been allocated on a basis consistent with the use of resources, with central staff costs allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use. Other support costs are allocated based on the spread of staff costs.

Charitable activities

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs

These include the costs attributable to the charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustees meetings and reimbursed expenses.

Taxation

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the charity is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

Fund structure

Unrestricted income funds are general funds that are available for use at the trustees discretion in furtherance of the objectives of the charity.

Financial instruments

Classification

Financial assets and financial liabilities are recognised when the charity becomes a party to the contractual provisions of the instrument.

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the charity after deducting all of its liabilities.

Recognition and measurement

All financial assets and liabilities are initially measured at transaction price (including transaction costs), except for those financial assets classified as at fair value through profit or loss, which are initially measured at fair value (which is normally the transaction price excluding transaction costs), unless the arrangement constitutes a financing transaction. If an arrangement constitutes a financing transaction, the financial asset or financial liability is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Financial assets and liabilities are only offset in the statement of financial position when, and only when there exists a legally enforceable right to set off the recognised amounts and the charity intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Financial assets are derecognised when and only when a) the contractual rights to the cash flows from the financial asset expire or are settled, b) the charity transfers to another party substantially all of the risks and rewards of ownership of the financial asset, or c) the charity, despite having retained some, but not all, significant risks and rewards of ownership, has transferred control of the asset to another party.

Financial liabilities are derecognised only when the obligation specified in the contract is discharged, cancelled or expires.
