This report includes information required by the Charities (Accounts and Reports) Regulations 2008 and the Statement of Recommended Practice for Accounting by Charities 2005

#### Administrative information

St Albans United Reformed Church Charity is a local church of the United Reformed Church in Great Britain and is a member church of Thames North Synod of the URC. It was registered on 21<sup>st</sup> August 2009 as Charity Number 1204421.

From the beginning of 2023 three churches - Homewood Road United Reformed Church, Trinity St Albans United Reformed Church and Greenwood United Reformed Church amalgamated to form St Albans United Reformed Church. It is based on two sites – Homewood and Greenwood situated respectively at Homewood Rd, St Albans AL1 4BH and at Watford Road, Chiswell Green, AL2 3HG. The above church buildings and two manses at 2B Jersey Lane, St Albans, AL4 9AB and 22 Charmouth Rd St Albans AL1 4SN are all vested in Thames North Synod Trust as trustees and held for the benefit of St Albans URC in accordance with the trusts applicable to URC properties.

The former Trinity Church building at 3 Beaconsfield Rd St Albans AL1 3RD and the cottage at 3 Beaconsfield Rd St Albans AL1 3<sup>RD</sup> were sold by Thames North Synod Trust in December 2024.

#### Structure, governance and management

The activities of St Albans United Reformed Church are overseen by the Elders' Meeting of the Church in accordance with the provisions of The Structure of the United Reformed Church determined by the General Assembly of the United Reformed Church, and supplemented by the rules of St Albans URC. The governing document of St Albans URC registered charity is a statement adopted at Church Meeting on 29<sup>th</sup> January 2023.

The Elders' Meeting is responsible for the financial administration of the Church, and the care and maintenance of both Church and Hall premises and the manses. The Church Meeting gives general guidance on the life and work of the Church.

The members of the Elders' Meeting of St Albans URC are the minister in pastoral charge (if any) and up to 12 members of St Albans URC nominated and elected by the members of St Albans URC in Church Meeting. Elders normally serve for 3 years, retire by rotation and are eligible for re-election. The members of the Elders' Meeting are the trustees of the registered charity during their period of service as elders.

The Elders' Meeting met 10 times during 2024. It is assisted in the administration of the Church and its property by the Finance and General Purposes Committee. The Church Meeting met 4 times in 2024.

#### Objectives and activities

As a local congregation of the United Reformed Church, St Albans United Reformed Church seeks to advance the Christian faith for the benefit of the public in accordance with the Scheme of Union of the United Reformed Church through its activities and the facilities offered to the community by its buildings.

The Trustees are aware of the Church's charitable purposes, and endeavour to make decisions that benefit all by:

- providing resources and facilities for public worship, pastoral care and spiritual, moral and intellectual development, both for the congregation and for anyone else who wishes to benefit from what the Church offers;
- promoting Christian values and service by members of the congregation to the community, for the benefit of individuals and society as a whole.

### Review of activities and achievements

For much of 2024, worship was possible only on the Homewood site, the Trinity site being closed in preparation for its sale at the end of 2024 and Greenwood's site being redeveloped to make it of much greater utility for the church's purposes in the future. It reopened in December 2024. The church continued to encourage members and friends to support a range of local, national and international charities financially and, in the case of a local food bank, in kind. A weekly Parents and Toddlers Group functioned during term time and there were some themed fun activity days for children during the holidays. A weekly café was operated by the church, originally in the height of winter, to provide a warm and social space for church members and the local community – its social value has been greatly appreciated and it has continued to operate once a month.

### Financial review

I am pleased to present the accounts for the period, which show an overall deficit of £36,014. This is the first set of accounts for this charity which covers 2024. However most transactions for the period to April 2024 were accounted for in the final Financial Statements of the three predecessor churches for the period to 30 April 2024. Reasons for the deficit include maintaining the Trinity site property during the whole year in preparation for its sale.

### 1 Accounting policies

#### Charity information

St Albans United Reformed Church Charity is a Charity registered with the Charity Commissioners in England and Wales under Charity Number 1204421

#### 1.1 Accounting convention

The financial statements have been prepared in accordance with the charity's governing document, the Charities Act 2011, and guidance provided by the Charity Commission for preparation of financial statements on the receipts and payments basis.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention modified to include revaluation of certain financial instruments at fair value. The principal accounting policies adopted are set out below.

#### 1.2 Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

#### 1.3 Charitable funds

The General fund is available for use at the discretion of the trustees in furtherance of their charitable objectives.

#### 1.4 Income

Income is recognised when the charity has received the funds.

Donations are recognised on receipt.

Legacies are recognised on receipt.

#### 1.5 Expenditure

Expenditure is recognised when incurred.

Expenditure is classified by activity.

#### 1.6 Cash and cash equivalents

Cash and cash equivalents include cash in hand and deposits held at call with banks
