The Trustees have pleasure in presenting their report and financial statements for the period ended 31st December 2024.

All trustees served throughout the period with the exception of P A Taylor and C F D Vendy who were appointed on 29 June 2024.

Structure, governance and management

The Charity is governed by the provisions of a Trust Deed dated 19 January 2023 and it was granted charitable status by the Charity Commission on 21 August 2023.

Three Trustees hold office while they act as Almoner, Charity Steward and Treasurer of the Provincial Grand Lodge of Worcestershire. Up to a further four trustees can be appointed by the Provincial Grand Master of Worcestershire for a period not exceeding 5 years. In selecting trustees for appointment, the Provincial Grand Master has regard to the skills, knowledge and experience needed for the effective administration of the Charity.

The Trustees meet at least four times per year working to a set agenda covering, *inter alia*, finances and investment, grant making and fund raising.

Objectives and activities

The Worcestershire Freemasons Charity is the public face of "Freemasonry in the Community". Its principal objectives are, for the public benefit, to:

- (a) relieve sickness and preserve health, advance education, and prevent or relieve poverty and financial hardship, amongst such persons as the Trustees consider from time to time to be in need of assistance;
- (b) further such other purposes (being exclusively charitable) as the trustees may from time to time in their absolute discretion consider appropriate.

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives, in planning future activities and setting grant making policies

In furthering these objectives, the Trustees will consider applications from any geographical area within England but preference will be given to the counties of Worcestershire, Warwickshire, and Staffordshire. The Trustees welcome applications from registered charitable bodies but, at their discretion, applications from other voluntary bodies and individuals will be considered. The goal is to make grants to a wide range of beneficiaries, particularly grassroots and small-to-medium-sized registered charities and voluntary organisations in the primary geographical areas of benefit.

In the period under review the Charity has operated only in the last quarter of 2024. In that period, it has benefited from donations received from masonic charities and Lodges based in Worcestershire. It has supported 'Teddies Loving Care' (TLC) by purchasing teddy bears for distribution to hospitals in the county. These are given to sick children – particularly those admitted to A & E and Minor Injury Units. It has also been able to help food banks, a charity connected to the local acute hospital and a national charity which will be supporting projects in Worcestershire. In the current year to date the Charity has been able to help local good causes with grants approximating £18000.

As a grant making charity, investment of funds is an important component of generating income and capital growth to support the Charity's activities over the long term. To that end, in the period under review, it has invested in COIF funds.

The Trustees are grateful for the support received from Charity Stewards and Lodges in Worcestershire and from 1st January 2025, the support of Royal Arch Chapters and their Charity Stewards. Without this generous help the Trustees would not be able to help our local communities to the extent that we are currently achieving.

Reserves policy

At 31 December 2024 the Charity had restricted reserves of £541 which relate to TLC. In addition, it had unrestricted reserves which the Trustees consider are adequate to fund the Charity's foreseeable activities.

Remuneration


No fees or reimbursements were received by the Trustees

Independent Examiners' Report

Respective responsibilities of Trustees and Examiner

The charity's Trustees are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("the Act"). 
