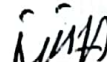

It is **mainly funded from Donations**, and without this continuous support, much of the **running and maintenance cost** required to keep the mosque operational could not be achieved. This highlights the essential role of individual donors in sustaining the charity's mission and daily services.

Summary of the main achievements of the charity during the year

The charity was established in **October 2023** with the core purpose of creating a **local mosque** to serve the **Turkish community**.

Key Achievements and Milestones

- **Initial Service Provision:** The charity immediately began providing services to the community by operating from a **rented local building** while pursuing a permanent facility.
- **Securing a Permanent Home and Renovation:** The major achievement of the year was securing a permanent facility. The charity contributed **£20,000** toward the building's purchase, working alongside **Turkish Diyanet London**, who holds the ownership. After renovating the premises, the charity successfully **moved into its current building around April 2024**, ensuring a long-term place of worship.
- **Full Operational Status:** The building now functions exclusively as the local mosque and is **open 7 days a week for prayers and services**, successfully achieving the founding mission and establishing a vital community hub.
- **Significant Financial Support:** Demonstrating exceptional backing, the charity independently **raised approximately £39,490** in total donations during its first year of operation.

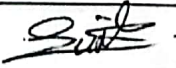
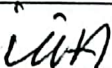
