1. Structure, Governance, and Management

IF AID is registered as a **Charitable Incorporated Organisation (CIO)** and operates under its governing constitution, in accordance with the **Charities Act 2011**. The charity is managed by its trustees, who oversee its compliance with legal and regulatory requirements.

The trustees are responsible for ensuring the CIO remains in good standing with the Charity Commission.

2. Objectives and Activities
