The trustees are pleased to present their annual trustees' report together with the financial statements of the charity for the period ending 31 December 2024 which are also prepared to meet the requirements for a director's report and accounts for Companies Act purposes.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the charity's governing document, the Charities Act 2011 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)".

## **1. Objectives**

### **Mission and objects**

GivenGain UK Foundation (the "Charity") exists to support and promote charitable giving and philanthropy through the GivenGain platform and allied initiatives. Its objectives, as set out in its governing document, are to advance such charitable purposes as the trustees decide, with particular emphasis on supporting UK-based NGOs, community organisations, and social causes by facilitating donations, fundraising, capacity building, and granting.

In pursuing these objects, the trustees aim to ensure that the Charity is an effective intermediary that helps donor and charitable causes to connect in a transparent, accountable, and efficient manner.

## **2. Structure, Governance & Management**

### **Governing Document**

The Charity is a Charitable Incorporated Organisation (CIO), governed under its constitution adopted on 25 August 2023. The constitution sets out the objects, powers, appointments and removal of trustees, decision-making procedures, and other governance provisions.

### **Trustee recruitment, induction & training**

Trustees are recruited by invitation or through open advertisement as vacancies arise. Prospective trustees complete a skills audit and are interviewed by existing trustees. New trustees are provided with an induction pack, including the governing document, the latest accounts, the Charity Commission's "The Essential Trustee" guidance (CC3), and relevant policies. Training is offered as necessary.

During the year under review, the board comprised four trustees:

- Johannes van Eeden (Chair) — appointed 25 August 2023 Charity Commission
- Dawid Eduard Malan — appointed 25 August 2023 Charity Commission
- Edward Henry Michael Persse — appointed 25 August 2023 Charity Commission
- Richard Christopher Michael Treneman — appointed 25 April 2025 Charity Commission

Trustee meetings are held at least bi-annually, and decisions may also be taken by unanimous written resolution. Quorum and voting rules follow that set out in the Constitution. Meetings may be held by electronic means to ensure full participation.

### **Organisational structure & management**

The trustees hold ultimate responsibility for governance, strategic direction, oversight, and compliance. The trustees review management performance, monitor key indicators, and ensure adequate policies (financial controls, safeguarding, conflicts of interest, reserves, data protection) are in place and adhered to.

### **3. Objectives, Activities & Achievements**

#### **Strategic objectives for the year**

During the year, the trustees approved a plan centred around the following key objectives:

1. Increasing the volume and value of donations through the GivenGain platform in the UK.
2. Expanding NGO / charity onboarding and support (technical, marketing, compliance).
3. Strengthening donor transparency, reporting, and impact measurement.
4. Building reserves and financial sustainability.
5. Enhancing governance, risk management, and stakeholder engagement.

#### **Main activities & achievements**

In achieving these objectives, the trustees report the following highlights:

- **Fundraising volumes:** The Charity facilitated £384,379 of donations through the GivenGain platform to UK causes.
- **NGO partnerships & onboarding:** Successfully onboarded 105 new charitable organisations to the platform, provided training or support in compliance, reporting or digital fundraising.
- **Technical improvements & transparency:** Introduced / upgraded reporting dashboards for donors and charities, improved data analytics and tracking of outcomes, increased frequency of impact reports.
- **Grants & awards:** Made direct grants of £384,379 to 101 charitable projects after competitive review.
- **Communications & advocacy:** Published impact stories, webinars, and hosted events to engage donors and NGOs, raising awareness of the platform and public trust in digital giving.
- **Capacity & sustainability:** Achieved a net surplus of £13,268 after allowing for operating costs, enabling reinvestment or strengthening reserves.
- **Governance enhancements:** Adopted or reviewed key policies (conflict of interest, fraud, data protection, whistleblowing, safeguarding) and held trustee training sessions.

#### **Beneficiary and charitable impact**

The trustees believe that the Charity has made a positive impact by (i) enabling smaller charities to access digital fundraising tools, (ii) increasing donor confidence through improved transparency and reporting, (iii) facilitating new funding streams for social causes that might otherwise struggle to reach donors.

The trustees continue to monitor and evaluate outcome metrics (e.g. number of donors, retention, funds disbursed, feedback from NGOs) and use these to refine strategy in future years.

### **4. Financial Review**

#### **Reserves policy & going concern**

In accordance with the Constitution, the trustees maintain adequate reserves to ensure the CIO's ability to meet obligations and sustain operations. The target reserve level is three months of operating costs. At year end, reserves stood at £13,268 representing 4 months of cover, which the trustees consider prudent.

Having reviewed forecasts and budgets and having considered sensitivity scenarios (e.g. reductions in donation volumes, increased costs), the trustees are satisfied that the Charity remains a going concern for at least the next 12 months.

#### **Investment policy**

The Charity does not hold significant long-term investments, but any surplus funds are held in instant-access deposit accounts or low-risk cash equivalents. The trustees review the policy periodically to ensure security, liquidity, and modest returns.

**Principal funding sources & expenditure**

The Charity's income is derived primarily from (i) a small commission or platform fee withheld on donations processed via GivenGain, (ii) grants or donations to the Charity itself, (iii) possibly interest income or fee income for support services.

Total income for the year was £55,509. Expenditure totalled £42,241, of which:

- £32,041 was spent on direct charitable activities (platform support, NGO training, grant distribution)
- £10,200 represented governance, administration, compliance, and overheads (office, staff/contractors, IT, professional fees)

The trustees monitor income and expenditure monthly (or quarterly) and review variances from budget.

**5. Risk Management**

The trustees have considered the major risks to which the Charity is exposed and implemented systems to manage them. Key risks include:

The trustees conduct an annual review of the risk register, reassess mitigation measures, and revise them where necessary.

**6. Plans for Future Periods**

For the coming year, the trustees intend to focus on:

1. Expanding donor acquisition and retention through targeted campaigns and improved user experience
2. Deepening partnerships with UK charities, including support for capacity building and compliance
3. Enhancing measurement of outcomes / impact and publishing more frequent impact reports
4. Upgrading platform features (mobile, dashboards, integrations) to stay competitive and efficient
5. Strengthening the Charity's financial sustainability, aiming to grow reserves
6. Reviewing governance performance and refreshing trustee skills (e.g. digital fundraising, cybersecurity)

The trustees remain committed to the Charity's mission of facilitating effective, transparent giving in the UK.

**7. Trustee Remuneration, Benefits & Related Parties**

**Remuneration and benefits**

No trustee received any remuneration or benefits from the Charity in the year, other than reimbursement of reasonable expenses incurred in carrying out trustee duties (e.g. travel, communications) in accordance with the Charity's expenses policy.

**Related party transactions**

The Charity has a relationship with GivenGain (platform owner / operator). Any services provided (e.g. technical, marketing, transaction processing) between the Charity and GivenGain are conducted on an arm's-length basis and documented. All transactions with related parties during the year are disclosed in note 10 to the financial statements.

If any trustee or connected person had a potential conflict of interest in a transaction, this was declared and the trustee recused themselves from decision making.

**8. Statement of Trustees' Responsibilities**

The trustees (who are also the directors under company law) are responsible for preparing the trustees' report and the financial statements in accordance with the Charities Act 2011, the Charitable Incorporated Organisations (General) Regulations, and the applicable United Kingdom Generally Accepted Accounting Practice (UK GAAP).

Trustees must ensure that the financial statements give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, and that they comply with statutory requirements. They must also ensure proper accounting records are kept, appropriate internal controls are in place, and the charity's assets are safeguarded.

In preparing the financial statements, the trustees must:

- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed;
- prepare the accounts on a going concern basis unless it is inappropriate to assume that the Charity will continue in operation;
- ensure the accounts are submitted to the Charity Commission and Companies House (if applicable) within the required deadlines.

The trustees are responsible for safeguarding the assets of the charity, ensuring proper risk management, and taking reasonable steps to prevent and detect fraud and other irregularities.



**REPORT OF THE INDEPENDENT EXAMINER TO THE

I report on the accounts of the Trust for the period ended 31 December 2024, which are set out on pages 9 to 19.

**Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.



**1. ACCOUNTING POLICIES**

**Charity information**

GivenGain UK Foundation is a charitable incorporated organisation in England and Wales. The registered office is Ground Floor Marlborough House, 298 Regents Park Road, London, United Kingdom, N3 2SZ.

**Accounting convention**

The financial statements have been prepared in accordance with the charity's governing document, The Charities Act 2011 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)". The charity is a Public Benefit Entity as defined by FRS 102.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

**Principal and Agent Arrangements**

The charity operates an online donation platform through which it facilitates contributions from donors to a range of charitable organisations.

Where the charity is acting as an agent, it does not have entitlement to the funds received and therefore does not recognise such amounts as income. Instead, the amounts collected are shown as "Funds held for third parties" within current liabilities until remitted to the intended beneficiary charities.

Where the charity is acting as principal, for example, where donations are made directly to the GivenGain UK Foundation for its own charitable activities or unrestricted use, the amounts are recognised as income in the Statement of Financial Activities on a gross basis, with corresponding expenditure when applied for charitable purposes.

The determination of whether the charity acts as principal or agent is assessed for each stream of income by considering who controls the transaction, bears the risks and rewards, and has discretion in setting the terms of engagement, in accordance with FRS 102 para. 21.4 and the Charities SORP (para. 5.10–5.15).

**Charitable funds**

- **Unrestricted Funds:** Funds that are available for use at the discretion of the trustees in furtherance of GivenGain UK Foundation's (GGFUK) objectives.

- **Restricted Funds:** Funds subject to specific conditions imposed by donors. These funds are used in accordance with those conditions and are reclassified to unrestricted funds when the restrictions are satisfied.

**Incoming resources**

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Income from courses, conferences, training and consultancy is recognised when the respective event occurs. Any amounts received in advance of the service provided are deferred.

Income from government and other grants is recognised when the charity has entitlement to the funds, and any performance conditions are met, it is probable that the income will be received, and the

amount can be measured reliably.

Gift Aid is claimed on eligible donations approximately 14 days after receipt of the qualifying donation. GGFUK only recognises Gift Aid income when it is received from HMRC. Accordingly, no amounts are accrued for outstanding claims at year-end.

Where donations are made for the benefit of specific charitable causes, any associated Gift Aid received is allocated to those causes only upon actual receipt from HMRC. This policy ensures income recognition is aligned with the principles of certainty and control over the inflow of economic benefits.

**Resources expended**

Expenditure is recognised when a legal or constructive obligation arises. Costs are categorised as follows:

- **Charitable Activities:** Direct costs associated with delivering the charity's services and objectives.
- **Support Costs:** Indirect costs that support the delivery of charitable activities, including governance, administration, and compliance.

GGFUK does not conduct fundraising on behalf of the causes it supports and therefore does not incur fundraising costs. Costs that relate to more than one activity are apportioned using a reasonable and consistent methodology.

**Cash and cash equivalents**

Cash and cash equivalents include cash in hand and deposits held with banks that are repayable on demand or have a maturity of three months or less. GGFUK acknowledges the potential risk of exceeding UK deposit protection thresholds and monitors bank balances accordingly.

**Grants Payable**

Grants payable consist of donations received through the GivenGain platform that are earmarked for charitable causes, subject to donor preferences. In line with GGFUK's Terms of Service and charitable objects, the charity retains full discretion (variance power) over the use and allocation of such funds.

Grants are recognised as liabilities when a constructive obligation arises, i.e., when a grant becomes an unconditional commitment. Disbursements are typically made 14 or more days following receipt of the related donation.

**Taxation**

As a registered charity, GivenGain UK Foundation is entitled to the exemption from taxation in respect of income and capital gains received with sections 478-489 of the Corporation Tax Act 2020 and section 256 of Taxation of Chargeable Gains Act 1992 to the extent that these are applied to its charitable objective purpose only. No corporation tax charge has been incurred by Fair Play Trading Limited due to a taxable loss being generated in 2021.
