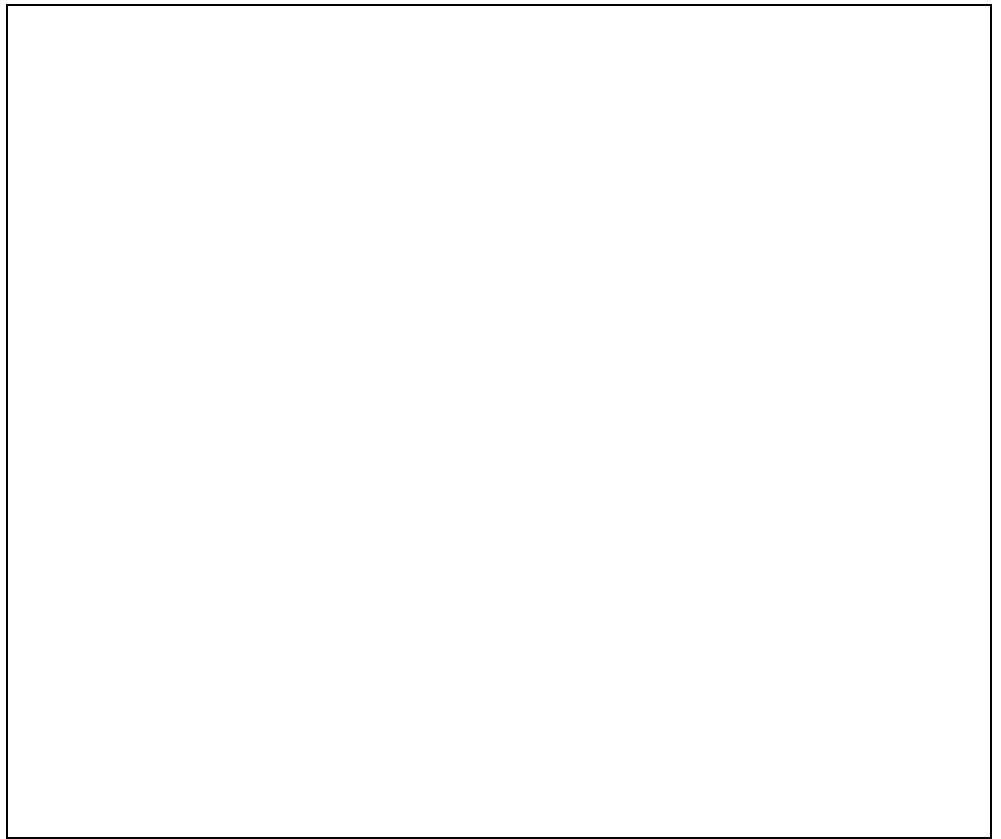
These are in line with Charity commissions public benefit guidance. We are here to serve the community and we hope that we will be able to do more in the coming months and years.
