REPORT OF THE TRUSTEES
FOR THE YEAR ENDED 30TH SEPTEMBER 2025

The trustees present their report with the financial statements of the charity for the year ended 30th September 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The charity operates from Stewarts Road Adventure Playground, providing inclusive play, youth development and community support for children, young people and families in the local area.

The trustees are responsible for overseeing the charity's activities and ensuring that the organisation continues to work towards its charitable purposes.

Big Up Communities exists to provide safe, inclusive spaces where children and young people can play and learn freely, build friendships, develop life skills and feel part of a community.

Our work centres around The Stewarts Road Adventure Playground, where we run youth sessions, holiday playschemes and community activities designed to support young people from a wide range of backgrounds.

Many of the families who access the playground face barriers to affordable activities or support services. Our sessions provide somewhere safe and welcoming for young people to spend time outdoors, learn new skills and connect with others.

The trustees have considered the Charity Commission guidance on public benefit and are confident that the charity's activities continue to provide clear benefit to the local community.

ACHIEVEMENTS AND PERFORMANCE

Charitable activities

This year has been another busy one for Big Up Communities. Alongside running regular youth sessions and playschemes, we have continued to strengthen partnerships, grow our volunteer base and improve the playground site. Our Open Gate Saturday sessions continue to be a core part of what we do, offering young people a place to play, socialise and take part in activities in a relaxed and supportive environment.

We also delivered several holiday playschemes, providing free activities and meals for local young people as part of the Lambeth HAF initiative. These sessions are particularly important for families during school holidays and allow us to connect with new families while maintaining relationships with existing service users.

Over the course of the year we:

- Engaged 484 individuals through programmes, volunteering and staffing
- Employed 13 sessional staff and 3 peer mentors
- Created 190 volunteer opportunities
- Provided over 400 hot, healthy meals to young people attending sessions and holiday activities.

Feedback from families consistently highlights how valuable the activities Big Up hosts at The Stewarts Road Adventure Playground are to the community. Parents have described the space as a "lifeline", particularly for families with children who have additional needs or limited access to affordable activities.

SEND Support and Inclusion

Our sessions are designed to be mixed ability and inclusive, and we are seeing a growing number of young people attending who require additional support.

Waiting times for diagnosis and support services are increasing, which means many families are struggling to find safe spaces where their children can participate fully.

In response, we have increased the number of 1:1 support places available during playschemes and continue to develop partnerships with organisations specialising in autism and SEND services to improve the support available to families.

Life Skills Programme

During the year we delivered a Life Skills programme for young people aged 16-25 with Special Educational Needs, funded by the National Lottery Awards for All programme.

The workshops focused on practical independence skills, confidence building and social development, helping young people gain experience that supports them as they move into adulthood. They also gained an Arts Award Accreditation. The programme has reinforced the need for more accessible opportunities for young adults with additional needs.

Fun Days at the Playground

We have run two Fun Days at the playground - one at Christmas 2024 and one in September 2025 (funded by the Mayor of London Community grant). The Fun Days provide an opportunity to promote the project, raise funds and bring the community together. We have activities such as arts and crafts, toasting marshmallows, DJs providing music, drumming workshop and refreshments.

Community Partnerships

Partnership working continues to play an important role in helping us improve the playground and expand what we offer. We continue to develop a strong partnership with London Play Design, a community interest company that supports adventure playgrounds across London. Through this collaboration, corporate volunteer teams have supported maintenance and development work on the site.

Through London Play Design's Adopt a Playground programme, Informa Tech funded and carried out significant refurbishment work at the site, including essential roof repairs and improvements to play structures and outdoor areas. This work involved over 130 corporate volunteers and was vital in helping secure the future of the playground.

The charity has also benefited from fundraising and organisational development support through the Greenlight Project, which has helped us strengthen our approach to fundraising and develop new partnerships.

Fundraising

Like many small charities, Big Up Communities relies on a combination of grants, donations and community fundraising to continue its work.

Our "Raise the Roof" campaign helped fund urgent repairs to the playground building. Community fundraising events and local support have helped raise awareness of the campaign and bring people together to support the playground.

We are extremely grateful to everyone who has supported our work, from individual donors and volunteers to corporate partners and grant funders.

Challenges

Running a community playground with limited resources continues to present challenges. One of the biggest issues during the year has been the need for significant building repairs. Addressing these issues required a considerable amount of time and fundraising effort, which inevitably reduces the time available for programme development.

However, achieving charity status in 2023 has opened up new opportunities for funding and partnerships, and we are beginning to see the benefits of this as the organisation grows.

FINANCIAL REVIEW

Financial position

The results of the years operation are set out in the attached financial statements.

Reserves policy

The Charity continues to seek further funding for its important work, and has long term aim of building general reserves (unrestricted funds) to a level equal to six months running costs, in order to protect itself from any unexpected fall in income.

FUTURE PLANS

The trustees remain committed to strengthening the charity and ensuring that the playground continues to serve the local community for many years to come.

Our priorities for the coming year include:

- Expanding SEND support and inclusive programming
- Securing Multi year funding to secure, grow and develop our activities
- Continuing improvements to the playground site
- Strengthening financial sustainability through diversified funding
- Increasing opportunities for volunteering and community leadership
- Developing new programmes that support young people's life skills and wellbeing

We believe that Stewarts Road Adventure Playground has the potential to become an even stronger community hub, and we look forward to continuing to help it grow and develop the charity's work.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Big Up Communities (formerly Big Up Films) is a registered charity 1204609 and was registered 9 September 2023. The company was established under a Memorandum of Association which established the objects and the powers of the charitable company and is governed under its Articles of Association

Recruitment and appointment of new trustees

The Trustees of the Charity are elected to the Management Committee at the Annual General Meeting or appointed between meetings by cooption, in accordance with the Articles of Association. The number of the committee members shall not be less than four but shall be subject to a maximum of seven.

Induction and training of new trustees

Trustees and committee members receive an induction pack with details of the constitution and about the work of the charity. Arrangements are also made to visit the Project to see the charity in operation.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The trustees are responsible for preparing the Report of the trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland".

The law applicable to charities in England and Wales, the Charities Act 2011, Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charity for that period. 

1. ACCOUNTING POLICIES

BASIS OF PREPARING THE FINANCIAL STATEMENTS

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

INCOME

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

EXPENDITURE

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

TAXATION

The charity is exempt from tax on its charitable activities.

FUND ACCOUNTING

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

REPORT OF THE TRUSTEES
FOR THE YEAR ENDED 30TH SEPTEMBER 2024

The trustees present their report with the financial statements of the charity for the year ended 30th September 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

For the public benefit, to relieve the needs of children aged 8-16, special educational needs of young people aged 11-25 and senior citizens through the provision of providing creative activities to improve personal and social development.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

In setting objectives and planning our activities for the year the trustees have given due consideration to the Charity Commissions guidance relating to public benefit. The Charity is committed to giving the community a voice. Using filmmaking, play, fitness activities and creative mixed media art projects as a tool to engage children (8-16), adults and senior citizens with the ongoing goal of improving their conditions of life through personal and social development. We aim to identify and address social issues that affect communities, with a focus on the underrepresented and marginalized. Each project is tailored specifically to meet the needs and interests of the group and designed to empower, engage, and inspire.

Big Up Communities was co-founded in 2005, when Sheena Callender and Peggy Shimmin recognized a need for accessible and affordable filmmaking workshop provision in their community. Since 2005, we have listened to the groups we work with, grown and developed our programmes, provision, and connections to ensure that each session achieves the best possible outcomes.

We rely on funding from grants and donations and this year we have received grants from Greenlight, Lambeth Council and the National Lottery.

Our organisation is currently based at Stewarts Road Adventure Playground and Youth Centre in South London, and we work with young people aged 8-16 including young people with special education needs (SEND). We have delivered Summer, Christmas, and Easter playschemes, funded by Lambeth Council; a Saturday Open Gate funded by the National Lottery. We have been fundraising with a few events including a one-man show with Peter Searles 'Through Peru' and a Sound Bath session where participants relaxed to sounds to help improve mental health.

We ran a Go Fund Me Campaign to raise money for the roof and we were front page news in the South London Press which helped to raise our profile in the community. We have also been funded by Greenlight to pay for Peggy and Sheena to concentrate on finding core funding and to help the project become more financially sustainable. We have an excellent team of staff who bring a variety of skills to the playground including skills in Mixed Martial Arts, sport, music, filmmaking and arts and crafts. Staff have undergone training in First Aid, Safeguarding Young People and Children, and Food Safety and Food Allergy and Intolerance Training.

We have been working with The London Play Design CIC since 2023. They have organised and facilitated over 5 corporate volunteering days, and linked the playground up with Lambeth probation services who facilitate community give back sessions every Sunday where the offenders are tasked with basic maintenance and gardening at the playground.

FINANCIAL REVIEW

Financial position

The results of the years operation are set out in the attached financial statements.

Reserves policy

The Charity continues to seek further funding for its important work, and has long term aim of building general reserves (unrestricted funds) to a level equal to six months running costs, in order to protect itself from any unexpected fall in income.

FUTURE PLANS

We will be working hard to raise money for the playground facilities and building and have plans for fundraising events in 2024 and 2025.

London Play is going to include Stewarts Road Playground in their Adopt-A-Playground programme. We will be matched with organisations, who will be sponsoring the playground's roof repairs, new play equipment; a chill out space and the refurbishment of the upstairs area.

We are planning a Christmas Fun day and Open days to raise funds and to reach out to the community. We will continue to apply for funding for holiday playschemes funded by Lambeth Council. We are hoping to secure funding to work with SEND young people aged 16-25 for a year when they will have the opportunity to develop Life Skills and gain an Arts Award qualification.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Big Up Communities (formerly Big Up Films) is a registered charity 1204609 and was registered 9 September 2023. The company was established under a Memorandum of Association which established the objects and the powers of the charitable company and is governed under its Articles of Association

Recruitment and appointment of new trustees

The Trustees of the Charity are elected to the Management Committee at the Annual General Meeting or appointed between meetings by cooption, in accordance with the Articles of Association. The number of the committee members shall not be less than four but shall be subject to a maximum of seven.

Induction and training of new trustees

Trustees and committee members receive an induction pack with details of the constitution and about the work of the charity. Arrangements are also made to visit the Project to see the charity in operation.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The trustees are responsible for preparing the Report of the trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland".

The law applicable to charities in England and Wales, the Charities Act 2011, Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charity for that period. In preparing those financial statements, the trustees are required to

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1. ACCOUNTING POLICIES

BASIS OF PREPARING THE FINANCIAL STATEMENTS

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

INCOME

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

EXPENDITURE

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

TAXATION

The charity is exempt from tax on its charitable activities.

FUND ACCOUNTING

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
