		Applications that meet the eligibility criteria are reviewed by the Trustees against the Foundation's three priority areas: • Education & Opportunity • Community • Environment & Wellbeing Each application is independently scored against these priority areas and the anticipated impact on children and young people. Scores and recommendations are then discussed at a Trustee Board meeting, where funding decisions are made collectively. Prior to any grant being awarded, the Foundation undertakes appropriate due diligence checks. This includes reviewing the organisation's governing documents, safeguarding arrangements, financial information, and regulatory status where applicable. Grant payments are only released once all due diligence requirements have been satisfactorily completed and the Trustees have formally approved the award. This process helps ensure that funds are distributed fairly, transparently, and in line with the Foundation's charitable objectives.

Thanks to our funding, over 100 children in Trowbridge, Chippenham, and Swindon were able to attend live theatre performances—many for the very first time. The second donation supported Upcycle, a community-led organisation in Bradford that runs bike maintenance training for young people from disadvantaged backgrounds. We helped fund a year-long programme for 35 young people, each of whom received a refurbished bike, safety gear, practical training, and ongoing support. The programme helps build independence, confidence, and skills—all while promoting sustainability.

In particular, Clause 10 sets out the process for appointment of trustees. Apart from the first charity trustees, every new trustee is appointed for a term of three years by a resolution passed at a properly convened meeting of the charity trustees. The first charity trustees were directly named in the constitution itself (Clause 9(4)) and were appointed for varying terms ranging from one to four years, as follows: • Debbie Gillespie – 4 years • Lorraine Weaving – 3 years • Suzanna Rolfe – 2 years • Ian Webb – 2 years • Sarah Robins – 1 year When appointing new charity trustees, the constitution requires that the existing trustees consider the skills, knowledge, and experience necessary for the effective administration of the CIO (Clause 10(2)). There is no provision in the constitution for election of trustees by members or external bodies; the appointments are made solely by resolution of the current trustees at their meetings.
