CITY OF MANCHESTER GYMNASTICS TRUSTEE REPORT FOR THE YEAR ENDING MARCH 2025

Legal Status and Purpose

City of Manchester Gymnastics is a Charitable Incorporated Organisation (CIO) and received charitable status on the 18th of September 2023. The organisation's purposes are:

- the promotion of community participation in healthy recreation for the benefit of those within the greater Manchester area by the provision of facilities for participating in the sport of gymnastics at all levels

Objectives

City of Manchester Gymnastics aims to be recognised as the leading provider of gymnastics in the Manchester area and to make a positive impact on the local community. The Board believes that taught well, sport and physical education develop qualities such as self-esteem, leadership and teamwork, making sport a force for good. City of Manchester Gymnastics looks to provide opportunities that enrich the lives of those involved, having a positive impact on members long after their training has come to an end, and to encourage lifelong involvement in the sport whether as participants, coaches, or officials.

Governance and Management

The charity is governed by its constitution and is managed by a Board of Trustees, all of whom have relevant managerial, business and financial experience. The Board is responsible for the strategic direction of the charity and oversees all its financial dealings. None of the Trustees are remunerated in respect of their position as Trustee.

Trustee Report

In the last 12 months the club has provided coached gymnastics activity to over 3,000 children. This is a testament to the vital activities the charity provides to the local community, week in week out.

Our gymnasts are offered opportunities to take part in competitions commensurate to their level of performance, competing at low level floor and vault competitions to competing internationally, representing Great Britain.

Our in-house competitions which are run frequently throughout the year involve some 600 recreational gymnasts and their families. The club's bespoke recreational award progression system continues as the backbone of the recreational development programme as well as providing additional income to the club.

Whilst the charity commenced operations just over a year ago, its roots stem from the Central Manchester Institute of Gymnastics which held its 50th Anniversary Celebration in January 2025, bringing together over 250 past and current members along with several dignitaries from the sport to receive awards and reminisce about their involvement with the club. We have a long and estimable record as a sports provider, which is a testament to the clubs' founder Colin Leigh, whose distinguished service to the sport of gymnastics spans over 6 decades.

The charity proudly boasts 7 High Performance coaches in its coaching team of 20 qualified coaches. We have 23 volunteer helpers, 9 qualified officials, 3 of whom are international brevet judges and 1 British Gymnastics' apprentice. We work with several schools providing work experience opportunities for a number of local students (3 in the current reporting year).

The charity provides gymnastics training for young members of Manchester City Football Club' development programme in addition to therapeutic preschool gymnastics activity for preschool age burns victims in partnership with NHS Manchester.

Competitive Achievements

At this year's Junior European Championships, Evan McPhillips was part of GB's successful Gold winning team.

The club competed in the European Gymnastics League reforging a friendship with Prague Gymnastics Club, the team of Sammy Cotter, Lucas Morris, Harry Nicholson and Jack Farrell finishing 10th.

At the British Grades Finals, Ollie Bowen and Thomas-Tyler Lee helped the Northwest win Team Gold in the Under 12 Bob Currier competition.

Sammy Cotter became the Welsh Junior Champion (under 16) and gained a place in the Welsh National Squad.

At the English Championships CMIG won 5 Gold medals in total and there was English squad selection for Joe Feery, Jed Solomon, Jamiah Richards-Leacock.

Evan McPhillips became the English Junior Champion taking the All-Around gold, the gold on floor and the gold on rings.

Jamiah Richards-Leacock took gold on Vault with Morris taking gold on P bars.

Jack Farrell took bronze on high bar, Lexi Mortimer came 6th on Floor, Anabelle Green was 4th on A bars.

At the Northwest Development competition Sophie Jenkinson won bronze.

At the British Championships – Lucas Morris won Gold on P bars, Evan McPhillips won 3 silvers, Jamiah Richards-Leacock won 2, and Lexi Mortimer successfully qualified to the Senior category, Anabelle Green took silver on A bars.

Evan McPhillips, Sammy Cotter and Akyra Rodgers-Plumber gained British National Junior Squad selection

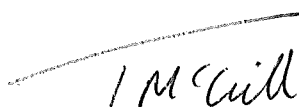
Evan and Akyra were selected for Junior European Championships; however Akyra unfortunately had to be withdrawn due to injury.

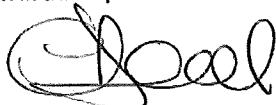
Independent Examiner's Statement

1. General Information

City of Manchester Gymnastics is a charitable incorporated organisation registered with the Charity Commission, registered charity number 1204758. The principal address is Garratt Way, Manchester, M18 8HE.

2. Accounting Policies

2.1. Basis of Preparation of Financial Statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)", Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Charities Act 2011.

The charity is a Public Benefit Entity as defined by FRS 102.

2.2. Incoming Resources

These are included in the Statement of Financial Activities (SoFA) when:

- the charity becomes entitled to the resources;
- it is more likely than not that the trustees will receive the resources; and
- the monetary value can be measured with sufficient reliability.

2.3. Resources Expended

Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

2.4. Tangible Fixed Assets and Depreciation

Tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses. Depreciation is provided at rates calculated to write off the cost of the fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

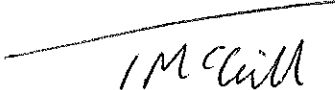

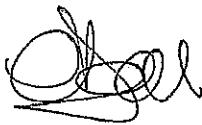
