## Charity Details

New trustees are recruited by the existing trustees based on their capability and experience.

## 2024-25 Activity

Following a successful festival in the summer of 2024, the Trustees decided not to run a festival in 2025 and to review the future of the charity later in the year. New local initiatives and venues have made it difficult to recruit volunteers to assist with the running of events, and after much thought the Trustees and management committee resolved on 12 December 2025 to cease operations and to close the charity.

## Public Benefit

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

The Charity's Objects are 'To advance the education of the public in the arts ... in Winchcombe and the surrounding area, and the Trustees have resolved to support two local charities to further these objectives in the future.

## Financial Review





## **Charity Details**

## **Management**

The charity is managed on a day-to-day basis by a committee of 3 people, i.e. Ed Arnold (chair), JoAnne Freeman & Charlie Bagnell. This committee is aided by a larger group of volunteers closer to and during the festival itself.

The trustees provide guidance to the operating committee and provide oversight of their activities. New trustees are recruited by the existing trustees based on their capability and experience.

## **2023-24 Activity**

The charity ran a successful festival in the summer of 2024. Overall, the Committee were able to look back with satisfaction on a successful week featuring a broad range of mainly musical events attended by almost 1,000 people. As with previous years, the delayed preparation of the printed brochure and other marketing material meant that ticket sales started very slowly. However, thanks to a lot of hard work by the committee in the last few weeks, attendee numbers and ticket sales were ultimately close to the numbers budgeted.

The Festival Week (May'24) featured 16 events plus a drinks reception for Friends of the Festival. The events covered a wide range of musical art forms, split as follows:

We ran seven events that were free to enter but were generously supported by donations and sponsorship. This is in line with our mission to make the arts accessible to all. Also, in our pursuit of accessibility, we offered £1 tickets to 18 and under at all ticketed events. Our venues were spread across the town and included St Peter's Church, Sudeley Castle, the Abbeyfields Centre, The Lion Inn and Winchcombe WMC.

## **Public Benefit**

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

The Charity's Objects are "To advance the education of the public in the arts, in particular by operating an annual or biannual arts festival in Winchcombe and the surrounding area".

In that context, our 2024 festival programme provided education and enjoyment to the people of Winchcombe and surrounding areas across a range of musical genres and the spoken word. As trustees and committee, we are proud to have provided the festival for the town and are confident we have acted in accordance with our Objects.

### **Financial Review**

Accounts are prepared on a Receipts and Payments basis. The charity was incorporated as a CIO on 25 September 2023; comparative figures for the year ended 31 July 2023 are shown for information purposes, and report the results of the festivals held in September 2022 and June 2023.

The charity organised the Winchcombe Festival in June 2024 and reported net receipts of £2,510. Thanks are especially due to the Tewkesbury Borough Council for a grant of £3,000, without which the Festival would have suffered a small deficit.


