This ranges from yoga and mindfulness in primary schools, to group sessions on a range of topics including anxiety, friendships, neurodiversity and grief in secondary schools as well as one-to-one counselling and art therapy for those with the highest level of needs, who have not met the threshold for child and adolescent mental NHS support, or who are unable to access the support provided.

B provided this vital service in four primary and one secondary school in and around Brackley. This has supported approximately 250 children improving their mental health and wellbeing. 


