Para 1.17 and 1.19	<p><b>Open to the Community</b> Putney Bridge Canoe Club (PBCC) is a club affiliated to PaddleUK/British Canoeing and operates from Barn Elms, in the London Borough of Putney. PBCC welcomes members from all areas of Greater London. As we have minimal facilities, suitable only for storing the equipment required for our paddles, we rely on the hospitality of our neighbours, Barn Elms Boathouse and South Bank Sailing Club, providing our members with access to their changing room facilities and water supply respectively. We run our river activities from Barn Elms and hire the Janet Adegoke swimming pool (located at Bloemfontein Road, W12 7DB) to offer pool sessions once-a-week. We also occasionally hire the artificial whitewater courses at Lee Valley White Water Centre (LVWWC), to provide members with an opportunity to experience this type of kayaking in a controlled environment.</p> <p>We offer one free-of-charge Thames paddling session to Trial Members (prospective members who have been assessed at the pool and deemed ready to paddle on the Thames). These sessions are free-of-charge for PBCC members.</p> <p>Pool sessions are open to members and non-members and the charge to participants is intended to recover the costs incurred for the hire of the pool from GLL/Better. PBCC has joined forces with Chiswick Pier Canoe Club (CPCC) to</p>

		<p>ensure that pool session capacity is maximised and all lifeguarding requirements are met.</p> <p>Pool sessions are the pathway for novices to be introduced to the basic safety requirements and paddling skills required to take part in Thames paddling sessions and join PBCC, if they wish to do so. They also offer the opportunity for experienced paddlers to refresh rescue and self-rescue skills. Given the small number of facilities offering paddlesport activities within the safe environment of a pool, PBCC's pool sessions attract a significant number of paddlers from other Greater London clubs.</p> <p><b>Membership Numbers (see Attachment 1)</b></p> <p>Although membership tends to fluctuate year-on-year, in 2024 PBCC has maintained a healthy base in excess of 100 members.</p> <p>In order to maximise participation opportunities for members of all ages and employment status, our scheduled paddles take place both on weekdays - on Tuesday evenings, thus facilitating access for those in employment, and Wednesday mornings, which are particularly popular with retirees and freelancers - and at weekends on Saturday and Sunday mornings.</p> <p>PBCC has a significant number of members in the &gt;46 years age group, as the club's activities are particularly well-suited to individuals in their middle years who are looking to develop new skills, enhance their physical and mental wellbeing and maintain an active lifestyle. Accordingly, membership applications from this demographic are especially encouraged.</p> <p>We welcome new members with prior experience as well as those without.</p> <p>Membership runs with the calendar year. For new members who join the club after 1 September, their initial membership period runs until the end of the following year, therefore covering a period up to 16 months.</p> <p><b>Activities</b></p> <p>PBCC carried out the following activities during the relevant period:-</p> <ul style="list-style-type: none"><li>• Thames paddles (standard and racing);</li></ul>

- Whitewater trips, including trips to LVWWC;
- Sea kayaking trips;
- Pool sessions (Janet Adegoke swimming pool).

**Thames Paddles**

Paddling sessions departing from and returning to the club's base at Barn Elms took place on a regular schedule of 4 (four) sessions per week, each lasting around 3 (three) hours, of which approximately 2 (two) hours are spent on the water, with the remainder of the time spent preparing for the paddle (including allocating equipment and providing a pre-paddle briefing) and cleaning and putting the equipment back in the club's container. During the relevant period, approximately 180 paddling sessions were run on the Thames, i.e. around one session every other day, with more than half of the club members participating in one or more sessions.

Depending on demand, PBCC also ran ad-hoc beginners' sessions, which are shorter and take place at low water, to minimise risk and ease newcomers into paddling in a moving water environment.

**Racing**

The small but committed Racing Group continued to operate, especially during the warmer months, under the guidance of PBCC's Racing Team Leader, who introduced existing and new club members to K1 and K2 racing boats and surfskis.

**Whitewater Trips**

PBCC traditionally joins the bi-annual whitewater trips to the River Dart in Devon, organised by Cherwell Canoe Club. Due to environmental constraints, these take place in the autumn/winter months. In the relevant period, two weekend trips were run, on 9-11 February and 15-17 November 2024. PBCC returned the favour by inviting Cherwell Canoe Club members to join the club's trips to LVWWC, when it hires on an exclusive basis the Centre's Legacy Course for two hours. One trip was organised in the relevant period, on 27 July 2024, which saw a good turnout. The charge to participants, as in the case of the pool sessions, is intended to cover the costs incurred by the club for the exclusive hire of the facilities, which are operated by Better on behalf of the Lee Valley Regional Park Authority.

**Sea Kayaking Trips**

	<p>PBCC organised a sea kayaking trip aiming to circumnavigate Hayling Island, off the south coast of England (Hampshire), on 13 April 2024. Due to unsuitable environmental conditions, the plan was curtailed to a shorter paddle in the Langstone Harbour area.</p> <p>PBCC's plans to run more sea kayaking trips during the spring and summer months of 2024 did not come to fruition due to the unavailability on health grounds of the Sea Kayaking Trip Leader, but it is hoped that such a programme can be developed in future years.</p> <p><b>Pool Sessions</b> As explained above, PBCC offers access to its pool sessions, which are held every Wednesday evening from 20:00 to 21:00 at the Janet Adegoke pool in White City, to both members and non-members.</p> <p>During these sessions, novices are introduced to the basic safety and paddling skills required to take part in Thames paddling sessions, as it is not deemed appropriate to permit beginners to paddle on the tidal section of the Thames without any prior introduction to basic paddling techniques, making a wet exit from a capsized boat and re-entry after a capsize.</p> <p><b>Leaders</b> PBCC is continuing to develop the skills of its Trip Leaders and plans to increase their number, encouraging members to undertake the pathway of PaddleUK/British Canoeing's awards and qualifications, both on a personal basis and with the club's support.</p> <p>We are working on the development of a training programme for Trip Leaders to ensure compliance with PaddleUK/British Canoeing's Standards for Deployment.</p> <p><b>Welfare Officer</b> The Welfare Officer (WO) provides advice regarding safeguarding and protecting adults at risk and children, promoting good practice and co-ordinating action within the club following receipt of any concerns or referrals.</p> <p>The principal focuses of the role are ensuring all policies and codes of conduct are up-to-date, and any changes in national legislation and guidelines from PaddleUK/British Canoeing are accessible to the club's Trustees, Officers, Trip</p>

		<p>Leaders, Volunteers and members, to ensure the safety and welfare of everyone involved in the club's activities, as well as to comply with legislative requirements and PaddleUK/British Canoeing's Standards of Deployment.</p> <p><b>Progress against action plan targets (Safeguarding and Health &amp; Safety):-</b></p> <ul style="list-style-type: none"> <li>• Safeguarding training: all Trustees/Committee members and Trip Leaders have completed the necessary courses to be compliant.</li> <li>• PBCC has put in place the following Policies: Code of Conduct; Safeguarding Policy; Health and Safety Policy Statement (all made available, together with the Constitution, to all club members) and is finalising a Financial Policy and Guidance (soon to be ratified by the Trustees, but with its principles already being implemented).</li> <li>• PBCC has also carried out a revision of its 2023 General Risk Assessment to take into consideration comments received from PaddleUK/British Canoeing and the second edition of the Port of London Authority's Tideway Code (2024). PBCC will continue to review and revise said Risk Assessment every 12 months, or whenever there is a significant change to the Tideway Code, or a material incident occurs. The General Risk Assessment is also distributed to all club members.</li> </ul> <p><b>Liaison with other Clubs in the Area</b> PBCC continued to develop its long-established links with CPCC and Battersea Canoe Club.</p>
<p>Statement confirming whether the trustees have had regard to the guidance issued by the Charity Commission on public benefit</p>	<p>Para 1.18</p>	<p>The Trustees have given serious consideration to the Charity Commission's general guidance on public benefit and, in particular, the promotion of health and wellbeing through the pursuit of paddlesport activities in central London. PBCC offers the opportunity to anyone living in Greater London, with or without prior experience, to participate in frequent and regular paddling activities at minimal cost. However, the club may impose an upper limit on the number of participants in a given activity, to ensure that their safety and well-being is prioritised.</p> <p>The main activities, as described above, are:-</p>

		<ul style="list-style-type: none"> <li>• 4 (four) standard Thames paddling sessions per week throughout the year, free-of-charge to members (all necessary equipment, including boat, paddle, BA and spraydeck are provided by the club);</li> <li>• 1 (one) Thames paddling session, free-of-charge, for Trial Members (all necessary equipment, including boat, paddle, BA and spraydeck are provided by the club);</li> <li>• numerous racing sessions every week, arranged by the Racing Team Leader, free-of-charge to members (all necessary equipment, including boat, paddle and BA are provided by the club);</li> <li>• 1 (one) pool session each week throughout the year, open to members and non-members (all necessary equipment, including boat, paddle and spraydeck are provided by the club); the charge to participants is only intended to recover cost of pool hire;</li> <li>• The club continues to develop links with other kayaking clubs, to offer members further opportunities to engage in various paddlesport disciplines and extend their interest, range and skills.</li> </ul> <p>The activities offered by PBCC have a beneficial impact on the health and well-being of the participants, regardless of their ages and abilities, and foster social interaction.</p>

Para 1.20	<p>For many years PBCC provided regular and frequent kayaking opportunities on the Thames in central and west London and in the controlled environment of a swimming pool, while operating as an unincorporated association. In addition, the club organised trips to whitewater rivers and seaside locations to expand members' access to multiple disciplines, such as whitewater and sea kayaking and kayak surfing.</p> <p>After careful consideration in 2022 and at the beginning of 2023, the General Committee's recommendation that PBCC apply for registration as a Charitable Incorporated Association ("CIO") with the Charity Commission ("CC") was voted on and ratified by club members at an Extraordinary General Meeting held on 2 February 2023. The principal driver for the application was to ensure the club has appropriate governance and management, so that the mission of providing affordable and accessible participation to paddlesports in the London area could be continued and developed.</p> <p>In order to achieve CC accreditation, the three trustees-elect tailored the CC's association constitution template and produced an appropriate constitution, Code of Conduct and Safeguarding Policy.</p> <p>Following registration, the Trustees have continued to develop governance measures,</p>

		<p>procedures and guidelines, which are distributed to all club members, as required.</p> <p>Please also refer to <b>Summary of Main Activities</b> above.</p>
