

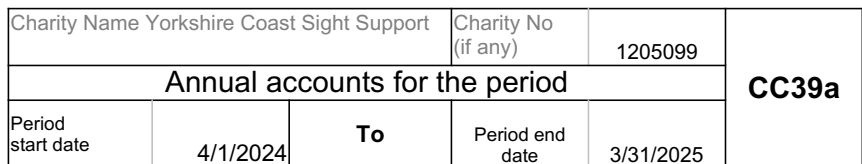
Yorkshire Coast Sight Support (YCSS) were, as a charity registration number 224245, struggling to recruit new trustees. The main problem concerning potential trustees was the liability issue associated with charity trusteeship. Even though the charity insured against the liability, there was a lack of confidence in insurers paying out, if a claim became necessary!

The solution was to change the charities structure from a charity to a Charitable Incorporated Organisation (CIO). Not only did this structural change offer potential trustees the protection of limited liability but also gave the charity the chance to review and strengthen its constitutional documentation.

The charitable objectives of Yorkshire Coast Sight Support have not changed, in fact they have not changed in the 90 years we have been operating, we will continue to support the visually impaired residents of the Scarborough Borough.

YCSS will continue operating as a charity 224245 up until the end of their financial year, March 31st 2026. At this point the charity 224245 will be closed and YCSS will continue providing its services as Yorkshire Coast Sight Support CIO 1205099.

The process of change has taken longer than anticipated, however, this structural change has resulted in new enthusiastic trustees who, in partnership with the outgoing charity trustees, are overseeing the change to a CIO, a change very much welcomed and supported by our service users.
