Objectives and Activities

The main purposes of the charity are to:

- Relieve persons who are in conditions of need, hardship or distress, sick, convalescent, disabled, handicapped, infirm or in need of financial assistance. To further the education (including social and physical training) of children. To assist people who have served in the armed forces and their dependents by advancing any lawful charitable purpose at the discretion of the Directors.
- Award funding in the form of grants to other charitable organisations which have as their purpose the relief of sickness, disability or handicap. The charity committed to support Operation Smile in 2025, which provides surgical procedures for children suffering from cleft palate in countries where access to such surgery is otherwise cost prohibitive or access is otherwise difficult.
- Support initiatives through grants to relevant third parties in order to provide physical and emotional support to cancer patients undergoing treatment.
- Provide funds to research organisations engaged in preventing or alleviating illness and disease and the operation of hospices and respite care.
- Provide support to communities and parents to improve and facilitate access to education or providing materials which support child friendly places of learning or distance learning.

During the year the company continued to operate and deliver its plans to fundraise with the intention of fulfilling its main charitable purposes.

In carrying out the charity's purpose, the guidance issued by the Charity Commission on public benefit has been followed.

Achievements and Performance

The charity began the year with £9,983 in the bank, Further funds were raised during 2025 with the purpose of supporting Operation Smile and other worthy causes. Operation Smile carries out work to provide world-class cleft surgery and care in more than 30 countries.

Financial Review

The charity received donations of £57,111 in the year ended 30th September 2025. The charity donated £57,000 to Operation Smile in the year to fund cleft operations. Funds held at the year-end totalled £10,119 after bank charges and interest received.

The current reserves are held with an intention to fund future surgeries in relation to Operation Smile and any other identified worthy causes as the Trustees deem to follow the charity's objectives.

The reserve held at 30th September 2025 was £10,119.

The charity has no concerns over it's ability to operate as a going concern.

Structure, Governance and Management

The charity is governed by articles filed at Companies House in 2024.

The charity operates as a charitable company, registered at Companies House.

Trustees are selected on a voluntary basis in accordance with the articles and provided they are permitted by law to be so appointed.
