During the period from October 2023 to April 2025, the Charity delivered a sustained programme of events, communications and networking opportunities designed to educate, encourage and support individuals in discerning and stepping into their vocation, leadership and areas of service:

Key achievements during the period included:

- Delivering two Stronger Conferences, each running over five days, engaging approximately 475 participants and supported by 190 volunteer speakers across the two years, addressing themes aligned with the Charity's purposes including leadership, culture, entrepreneurship, communication, business and digital engagement
- Working in collaboration with 25 partner organisations in the delivery of the Stronger Conferences, primarily for the purposes of signposting participants to additional resources and support, and extending the reach and accessibility of the Charity's work
- Publishing 77 weekly *Stronger* email communications, freely available to subscribers, consolidating teaching and insights from events and providing practical tools and reflection to support learning and personal application
- Producing and sharing regular social media content, including summaries and excerpts from conference talks, to extend the accessibility and reach of the Charity's educational resources
- Hosting a number of standalone webinars, enabling participants to learn from peers and mentors through shared experience, practical examples and reflection
- Facilitating coaching connections within the Charity's network, including through an affiliate coaching organisation, providing additional support and encouragement for individuals taking next steps in line with their purpose.


