In summary, the main activities in relation to the above purposes of the CIO have been meeting regularly, setting up a bank account, responding to offers of financial support and preparing for requests for grants.

The trustees of the CIO have had regard to the guidance issues by the Charity Commission on public benefit.

Achievements and Performance

The main achievements of the charity have related to the setting up and establishment of the CIO. The charity now has a bank account and has now been introduced to churches within the Preston area. It has a website with further information about the charity, the statement of faith and the grant making policy. As yet there have been no requests for financial support and therefore there are currently no beneficiaries and no wider benefits to society as a whole.

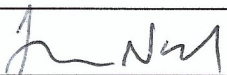

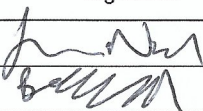
