**Trustees' report for the period ended 31 March 2025**

The charity was registered on 7th November 2023 and will commence trading on 1st April 2025.

The Charity has the following objectives:

To promote for the benefit of the inhabitants of the town of Rye and the surrounding area, the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with a view of improving the condition of life of said inhabitants.

The promotion of community participation in healthy recreation for the benefit of the inhabitants Rye and the surrounding area by the provision of facilities for swimming and for the playing of other sports, recreation and leisure activities.

To further or benefit the residents of Rye and the surrounding area and neighbourhoods, without distinction of sex, sexual orientation, race or of political, religious or other opinions by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure time occupation with the objective of improving the conditions of life for the residents.

In furtherance of these objects, the CIO has worked to secure the continued operation of the leisure centre in Rye. This would be done by taking over the lease of Rye leisure centre owned by East Sussex County Council and operated by a contracted third party. The leisure centre includes a swimming pool, a gym and a sports' hall. The activities of the financial year therefore focused on 1) From June 2025, raising funds to secure enough working capital for 3 years of operation 2) Negotiating a lease with local government organisations 3) Preparing for a start date and 4) Securing funding for necessary repairs and updates.

The CIO is very grateful to the funders and the many people of Rye and the surrounding area for their generous donations that provided the necessary capital allowing the opening of a community operated leisure centre on 1st April 2025.
