The REQUEST FOUNDATION will not fund the entire cost of projects but will partially fund those elements of a project which further our charitable purpose as follows: -

- Personal development activities (including pre-project training).
- Disseminating the outcomes of the project.
- Where the participant's project would not be achievable without such help the REQUEST FOUNDATION will also consider
- Personal travel, accommodation and equipment costs.

All successful applicants will be required to produce a post-project report, which specifically details how the project satisfied their growth and personal development needs.

Trustees will review project reports to assess how funds have impacted the life of beneficiaries, to review and improve this policy and to evaluate the work of the foundation.
