



# Market Field Football Club

## Trustees' Annual Report 2023–24



## Objectives and Activities

The purpose of the club, as set out in its constitution, is, for the public benefit, to relieve the charitable needs of children with Special Educational Needs (SEN) in Essex in particular but not exclusively, through the provision of facilities and opportunities for playing football.

### Activities

This year, we have established the club — by providing weekly football training sessions during term-time for children from Market Field school; marketing them to parents, guardians, and children; and fostering a sense of community and membership around the club.

We have had regard to the guidance issued by the Charity Commission on public benefit.

### Contribution made by volunteers

Our sessions are run entirely by volunteers, who freely sacrifice their time to provide fun and structured opportunities for the children to engage in sport. They are also enabled by parents and guardians who supervise their children while attending. The club is entirely built on the efforts of these volunteers; we could not exist without them.



## Achievements and Performance

We have established a football club that at present has a connection with Market Field School, using their school field, and currently with children and family members from the school attending the club. We have 6 volunteer parent coaches and around 26 children on our books, with the average weekly attendance of around 16. We have witnessed incredible growth from the kids, not only their skills and understanding of the game, but also their confidence, understanding of teamwork, and most importantly how to encourage each other individually and collectively.

We have also witnessed a wonderful community feeling amongst the parents and carers of the club, creating long-lasting friendships among the different families.



## Financial Review

We took £687 in session subs from the start of our accounting period (22nd November 2023, the date we were registered with the Charity Commission).

We spent £556 from the start of our accounting period.

The club was in operation before our accounting period. We registered with the FA on 7th July 2023, and held our first training session on Saturday 9th September. Initial equipment was donated by the chairman. In this period, we took session subs (exclusively in cash, as we had not yet opened a bank account), and paid for safeguarding courses, DBS checks, and a gift for a club member undergoing surgery. These transactions are not documented in our accounts, as they fell before the start of our accounting period.

Our net cash position at the start of our accounting period was £176.

## Reserves policy

The club holds reserves to enable future purchases of equipment for training sessions, and community-building events for the club.

The club holds reserves of £307.

## Source of funds

The club's principal source of funds is session subs, paid by parents and guardians per child, per session.



## Risks

The club's primary risks are Safeguarding, people-dependency, reliance on donated access to playing fields, and lack of capital to absorb a financial shock.

### Safeguarding

As a charity working with children and young people under the age of 18, safeguarding is of paramount importance to us. We have a dedicated Welfare Officer with responsibility for ensuring the club abides by its Safeguarding Policy and the club seeks to take a proactive approach to ensuring the safety of all involved with the club.

### People-dependency

We rely entirely on volunteer coaches being available for each session. If the current coaches are unable or unwilling to continue, and we cannot recruit new volunteer coaches, we won't be able to offer training sessions.

In addition, we also rely on parents and guardians being able to supervise their children at training, and afford session subs.

### Access to playing fields

The generous donation of Market Field's pitches, which is reflected in our accounts, is another major dependency. Free access to the pitches helps us keep the cost of attendance as affordable as possible for our members and their families. Our income from session subs would currently not cover the cost of hiring these facilities on the market, so the loss of donated access to the pitches would force us to significantly increase the price of attendance.

### Lack of capital

Our small level of reserves as a new club means the club is less able to absorb financial stresses, for example if equipment is damaged or fails to last for as long as anticipated.



## Structure, Governance and Management

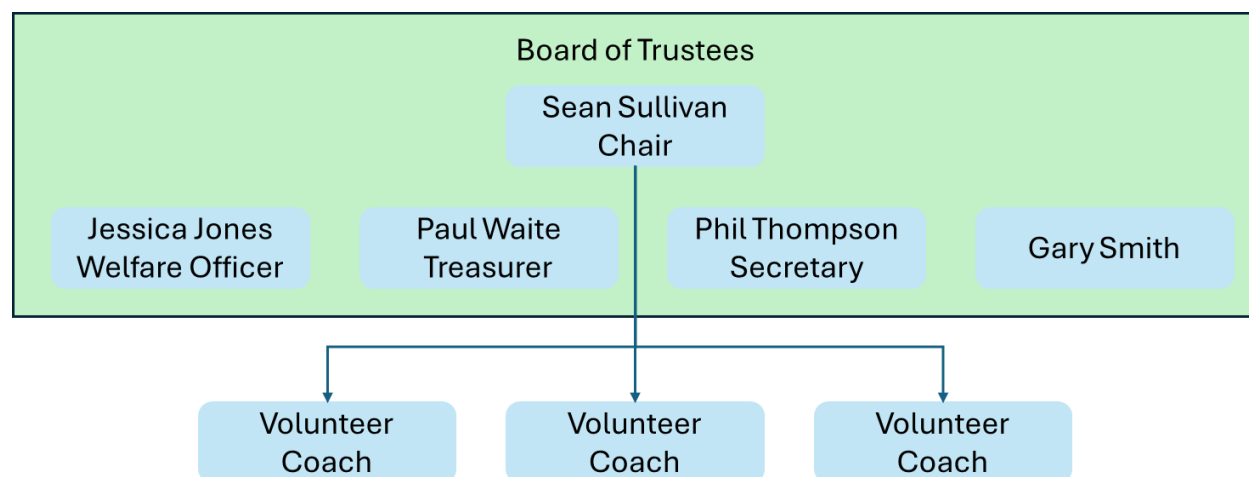
Our governing document is our constitution. It uses the 'foundation' model, where the only voting members are charity trustees.

We are constituted as a Charitable Incorporated Organisation.

Trustees are appointed by a resolution passed at a properly convened meeting of the charity trustees. The charity trustees must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

Trustees must undergo DBS checks, and take the FA's safeguarding training. In addition, the Secretary provides an induction pack containing key governance and policy documents.

As at the end of the accounting period, the club had five trustees, most of whom also act as volunteer coaches, in addition to which we had three volunteer coaches, all of whom operate under the overall leadership of the club Chair.



Given the very small size of the club, we do not operate with any subcommittees of the Board of Trustees.

The club is registered with the Essex Football Association under no. 105818.
