3.1.1	the advancement of the Christian faith in accordance with Baptist Principles and the Basis of Faith primarily but not exclusively within Machen and the surrounding neighbourhood; and

3.1.2 such other charitable purposes as shall, in the opinion of the charity trustees, put into practice the Christian faith in accordance with the Basis of Faith, including but not limited to: the prevention and relief of need, hardship and sickness; the advancement of education; and the provision of facilities in the interests of social welfare for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disability, financial hardship or social circumstances with the object of improving their conditions of life;

provided that the advancement of such purposes must be undertaken in a manner that is consistent with the Doctrinal Distinctives and Ethical Statements as may be adopted and amended by the Church from time to time in accordance with the provisions of the Church Handbook.

The church meets weekly on Sundays at 10:30am. This service is open to members and non-members and provides opportunity for people to offer worship to God, to hear Christian preaching and teaching and to meet and have fellowship with others.

The church also has a series of weekly meetings which people are invited to join in with, including:

Tuesday evening Women's meeting
Wednesday Bible study and prayer
Friday Evening – Youth Meeting
Sunday evening Youth worship and fellowship meeting

In addition to these regular meetings the church organises events for the public benefit including (for example):

Pop up café
Christmas craft evening
Carol singing and carol service
Evangelistic outreach services

The church also organises an annual away weekend for members.

The church also supports other charities and mission work including for example:

Maes Profundo (Church mission in Portugal)
Pont a medical support charity in Uganda
Compassion.



Achievements and performance

Summary of the main achievements of the charity during the year

This report is related to the first year of the charity's operation and, whilst Ebenezer Machen has existed for generations in the village, we have been pleased to see how the work has evolved over the first period of its operation as a CIO.

The church has grown significantly over the past year and we have reached a point where our regular services are reaching the capacity of the buildings that we use. We have had significant interest from the general public with a number of people coming to regular and other events to join in and explore the church in an open and welcoming environment.

Regular women's events provide an opportunity for women from the village to join in a social event with a core message about the love of Jesus and their value and worth as individuals and members of the wider community.

Giving and supporting mission

It has also been a blessing to be able to support other works and make contributions to the hard work that others are undertaking at a local and international level. We made sure that we are using the charity's resources responsibly and generously in this respect and have taken into account the Commission's public benefit guidance when making our decisions.

The appointment of our Church Missionary worker in November 2024 has been a key milestone for us and it has been exciting to see the work that we have been able to do flourish as a result. The church missionary worker has run a number of events within the church and reaching out for the benefit of the public over the period since appointment. Examples include youth meetings and women's events for the community.

Financial review

Brief statement of the charity's policy on reserves

The charity endeavours to keep a minimum of £5,000 in the Church Deposit account (equivalent to 3 months of expenditure). This figure seems to represent a prudent and sensible balance between holding funds unnecessarily that could be better used in other ways and ensuring that there is enough resource available to cope with needs that arise in the short term (e.g. remedial building work, or other unexpected requests for support).

At the year end, the charity held unrestricted cash of £66,000. These funds have accumulated in the last few years as a result of donations to the church. We envisage that the building where we meet will need a new roof in the near future (although we have done remedial work in the short term that will delay the expense). We also plan to continue supporting our Missionary worker, and we will consider other needs which meet our charitable objectives.

1 Accounting policies
