Para 1.17 and 1.19	The charity has been inactive since it was registered on 23 <sup>rd</sup> November 2023. This was due to a number of reasons. Firstly we found out that one of the original trustees was not eligible and so there was a delay in finding a replacement trustee, Jane Scott. Secondly, the charity had an informal agreement to have use of a retreat centre that was in the process of being constructed in Scotland. This centre would have been the ideal location to enable the Charity to fulfil many of its objectives including the performing Buddhist ceremonies and the running of meditation retreats and workshops. However due to problems with the wiring and the water supply the centre has not been able to be used or this current period. The issues are in the process of being resolved which should allow us to use the centre in the future. When we became aware of this delay, one of the trustees, Jane Scott offered to help. She was in the process of converting a disused shop which was part of her house into a residential annex. This would have freed up a room in her house which she

		would allow the NGA could use. Planning permission was applied for and had been moved to the committee stage by Jan 2024. She was told that this should be dealt with quiet quickly so our plan was to wait for the room to come available. However the process has kept being delayed so we have not been able to use the room in this period.
