INTRODUCTION

Included in this report are the aims of the Church and a commentary on the financial aspects of its work. This report has been prepared based on the activities and plans as they are known at the current time.

REVIEW OF THE YEAR

These accounts show an surplus of receipts over payments of £4259 for the year which has been added to reserves.

Income

Church income is primarily drawn from offerings and gift aid tax recovery

The Church premises are made available to a range of organisations who contribute letting income.

Grants are provided by the Circuit and the District towards the cost of the Community Lead

Expenditure

The major expenses are:

Payment of the Circuit Assessment which covers the cost of Circuit ministers and staff

Reimbursement of the cost of the Community Lead employed through the Circuit

Maintenance and utilities relating to the premises

Significant Transactions t appointed a Deacon from 1 September 2025 who will take on the responsibilities of the Community Lead role as part of her duties. The grants received cover a period beyond 1 September 2025 and any excess will be refunded.

The Community Lead has been able to assist the Church in providing community support for families through a coffee morning and creche, lunches, toast club, a meeting for older members of the community and providing a safe space for teenagers.

The Church acts as host to a community larder which provides support to members of the local community that are in need.

The Church has a Legacy Fund which held a balance of £48822 at 31 August 2025. The fund represents the balance of legacy monies that were given to the Church in earlier years. Although this fund is unrestricted as defined by charity law it is subject to the rules of the Methodist Church regarding its use. For this reason it is shown as designated funds in the Church Accounts. There are currently no specific plans for the use of this fund but it would be available to support the outreach of the church if required.

FUND BALANCES

At 31 August 2025 the cash resources on the general fund of the Church amounted to £41246 giving approximately 4 months cover for general expenditure. There are investments and cash resources on the Legacy Fund which amounted to £48822 which are available to support the Church when exceptional costs arise. The restricted funds are represented by cash resources.

PLANS FOR 2025 – 2026

The Church financial plans for the coming year have been prepared on the basis that giving by members, which is largely by monthly standing order, will continue at a similar level and that Gift Aid continues as currently. With this income, the letting receipts and interest earned on deposits the trustees are satisfied that there will be sufficient income and reserves to meet the ongoing expenditure.

The Church plans to support the work of the Community Lead for the forthcoming year by the provision of welcoming premises at no charge. With effect from 1 September 2025 the the Community Lead will be a member of the Circuit staff.

The organisation and resourcing of regular acts of worship open to members of the Church and non members alike.

The teaching of Christianity through sermons, courses and small groups.

The resourcing of pastoral work including visiting the sick and bereaved.

Taking religious assemblies in local schools.

Provision of chaplaincy services to the local university and other institutions.

Facilitating the provision of food and other supporting services to the local community.

PUBLIC BENEFIT

We confirm the trustees have had regard to the Charity Commission's guidance on public benefit.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governing document for the Church is the Deed of Union (1932) and Methodist Church Act (1976).

Detailed governance arrangements are outlined within the Constitutional Practice and Discipline of the Methodist Church by order of the annual Conference (CPD).

Day to day management of the Church is undertaken by the Minister and members of the Church Leadership Team.

TRUSTEE TRAINING

A range of guidance is produced by Methodist Connexion to support the effective running of the Church, specifically a leaflet "The Role of a Trustee in The Methodist Church" is given to all new Church Council members as induction to their role as trustees.

RELATED PARTIES

The Church is part of the Weald of Kent Circuit and is also accountable to the South East District and the Methodist Conference.

RISK MANAGEMENT

The major risks have been identified and recorded by the Church Council supported by the Finance and Property Committees, with professional advice taken as required. Income and Expenditure is monitored in total and is compared with the approved annual budget on a regular basis to detect trends as part of the risk management process.

SAFEGUARDING

Every person has a value and a dignity which comes directly from the creation of male and female in God's image and likeness. Christians see this potential as fulfilled by God's re-creation of us in Christ.

Among other things this implies a duty to value all people as bearing the image of God and therefore to protect them from harm.

The Church commits itself to following the practice and policies as established by the Methodist Connexion, government legislation and safe practice in safeguarding matters. The Church is also committed to the provision of support, advice and training to lay and ordained people that will ensure they are clear and confident about their roles and responsibilities in safeguarding and promoting the welfare of children and adults who may be vulnerable.

RESERVES POLICY

The reserves policy of the Church for general funds is to hold a minimum sum of four months expenditure excluding expenditure that is specifically covered by annual grants. The Church holds funds in its legacy fund which are available subject to appropriate approval from Connexion to meet any unforeseen item of major expenditure. The Church holds restricted funds which are available for donation to local needs and other charities, and grants received for later accounting periods.

NOTES TO THE ACCOUNTS

1. BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared in accordance with the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS102) (effective 1 January 2015) – (Charities SORP (FRS102)), the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS102). The Tonbridge Methodist Church meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2. FUNDS

The funds held constitute:

General Funds held for any purpose of the Church which are unrestricted.

Designated Fund consist of a legacy fund that has wide purposes defined in Standing Orders. This item is categorised as unrestricted.

Restricted Funds are held for the purpose of each fund and can only be used for the prescribed purpose of that fund.

Details of each material fund are disclosed in note 14 to these accounts. Any fund may be represented by more than just cash.

3. ACCOUNTING POLICIES

Basis

These accounts have been prepared on the basis of historical cost except that investments are shown at their market value at the end of the year, and on a receipts and payments basis.

Receipts Recognition and Resources Expended

Receipts and resources expended are included in the Receipts and Payments Account when the Church receives the funds and makes payments.

Grants

Where grants received by the Church towards specific expenditure the receipt is attributed to the period of the expenditure and any grant attributable to a future period is retained in restricted funds.

VAT

Since the Church is not VAT registered all input VAT is charged with the expenses to which it refers.

Investments

Investments are valued in the balance sheet at the market value at the year end. Investment income is included in the accounts when received and any gains or losses on revaluation at the year end are shown on the Receipts and Payments Account.

Cash Flow Exemption

The financial statements do not include a cash flow statement because, as a small charity, it has taken exemption for cash flow in accordance with FRS102, update bulletin one, in the preparation of these statements.

Fittings and Equipment

Expenditure relating to fittings and equipment is written off in the year of purchase.

4. INVESTMENT INCOME

The income consists of interest of £686 from deposits with the Trustees for Methodist Church Purposes, £1362 from deposits with CAF Bank, and dividends of £624 from listed investments.

5. OTHER RECEIPTS

Other receipts includes £13500 by way of grant towards the costs of the Lay Worker, refund of Methodist Pension request and donations.

6. PAYMENTS TO TRUSTEES

There were no payments to trustees for the current and previous year.

7. LAY WORKER

The lay worker is an employee of the Weald of Kent Methodist Circuit. The amount charged in the Receipts and Payments Account represents reimbursement to the circuit of this cost and the expenses incurred carrying out the lay worker's duties.

8. OTHER EXPENSES

Other expenses include the cost of cleaning the church premises and general administration.

9. INVESTMENTS

The Trustees for Methodist Church Purposes are the legal owner and custodian trustees of the legacy fund investments, which are all listed on a registered Stock Exchange.

10. BANK BALANCES

Funds are held by Charities Aid Foundation (CAF) and Santander Plc on behalf of the Church.

11. CREDITORS

The Accounts are prepared on a Receipts and Payments basis which does not require the disclosure of debtors and creditors. The Statement of Assets and Liabilities includes as a note the debtors, payments in advance and the creditors at 31 August 2025. The Trustees confirm that apart from the items shown the Church has no significant short or long term liabilities at 31 August 2025.

12. CAPITAL COMMITMENTS AND CONTINGENT LIABILITIES

At 31 August 2025 the Church had no capital commitments and no contingent liabilities were identified.

The Church financial plans for the coming year have been prepared on the basis that giving by members, which is largely by monthly standing order, will continue at a similar level and that Gift Aid continues as currently. With this income, the letting receipts and the grants that have been committed the trustees are satisfied that there will be sufficient income and reserves to meet the ongoing expenditure.

The Church plans to continue the work of the Community Lead for the forthcoming year.

Any purpose for the time being of any charity being a charity subsidiary or ancillary to The Methodist Church

The organisation and resourcing of regular acts of worship open to members of the Church and non members alike.

The teaching of Christianity through sermons, courses and small groups.

The resourcing of pastoral work including visiting the sick and bereaved.

Taking religious assemblies in local schools.

Provision of chaplaincy services to the local university and other institutions.

Facilitating the provision of food and other supporting services to the local community.

PUBLIC BENEFIT

We confirm the trustees have had regard to the Charity Commission's guidance on public benefit.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governing document for the Church is the Deed of Union (1932) and Methodist Church Act (1976).

Detailed governance arrangements are outlined within the Constitutional Practice and Discipline of the Methodist Church by order of the annual Conference (CPD).

Day to day management of the Church is undertaken by the Minister and members of the Church Leadership Team.

TRUSTEE TRAINING

A range of guidance is produced by Methodist Connexion to support the effective running of the Church, specifically a leaflet "The Role of a Trustee in The Methodist Church" is given to all new Church Council members as induction to their role as trustees.

RELATED PARTIES

The Church is part of the Weald of Kent Circuit and is also accountable to the South East District and the Methodist Conference.

RISK MANAGEMENT

The major risks have been identified and recorded by the Church Council supported by the Finance and Property Committees, with professional advice taken as required. Income and Expenditure is monitored in total and is compared with the approved annual budget on a regular basis to detect trends as part of the risk management process.

SAFEGUARDING

Every person has a value and a dignity which comes directly from the creation of male and female in God's image and likeness. Christians see this potential as fulfilled by God's re-creation of us in Christ.

Among other things this implies a duty to value all people as bearing the image of God and therefore to protect them from harm.

The Church commits itself to following the practice and policies as established by the Methodist Connexion, government legislation and safe practice in safeguarding matters. The Church is also committed to the provision of support, advice and training to lay and ordained people that will ensure they are clear and confident about their roles and responsibilities in safeguarding and promoting the welfare of children and adults who may be vulnerable.

RESERVES POLICY

The reserves policy of the Church for general funds is to hold a minimum sum of four months expenditure excluding expenditure that is specifically covered by annual grants. The Church holds funds in its legacy fund which are available subject to appropriate approval from Connexion to meet any unforeseen item of major expenditure. The Church holds restricted funds which are available for donation to local needs and other charities.

NOTES TO THE ACCOUNTS

1. BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared in accordance with the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS102) (effective 1 January 2015) – (Charities SORP (FRS102)), the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS102). The Tonbridge Methodist Church meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2. FUNDS

The funds held constitute:

General Funds held for any purpose of the Church which are unrestricted.

Designated Fund consist of a legacy fund that has wide purposes defined in Standing Orders. This item is categorised as unrestricted.

Restricted Funds are held for the purpose of each fund and can only be used for the prescribed purpose of that fund.

Details of each material fund are disclosed in note 14 to these accounts. Any fund may be represented by more than just cash.

3. ACCOUNTING POLICIES

Basis

These accounts have been prepared on the basis of historical cost except that investments are shown at their market value at the end of the year, and on a receipts and payments basis.

Receipts Recognition and Resources Expended

Receipts and resources expended are included in the Receipts and Payments Account when the Church receives the funds and makes payments.

Grants

Where grants received by the Church towards specific expenditure the receipt is attributed to the period of the expenditure and any grant attributable to a future period is retained in restricted funds.

VAT

Since the Church is not VAT registered all input VAT is charged with the expenses to which it refers.

Investments

Investments are valued in the balance sheet at the market value at the year end. Investment income is included in the accounts when received and any gains or losses on revaluation at the year end are shown on the Receipts and Payments Account.

Cash Flow Exemption

The financial statements do not include a cash flow statement because, as a small charity, it has taken exemption for cash flow in accordance with FRS102, update bulletin one, in the preparation of these statements.

Fittings and Equipment

Expenditure relating to fittings and equipment is written off in the year of purchase.

4. INVESTMENT INCOME

The income consists of interest of £704 from deposits with the Trustees for Methodist Church Purposes, £2366 from deposits with the Central Finance Board of the Methodist Church, £184 from deposits at bank and dividends of £912 from listed investments.

5. OTHER RECEIPTS

Other receipts includes £11000 by way of grant towards the costs of the Lay Worker and £5105 of donations

6. PAYMENTS TO TRUSTEES

There were no payments to trustees for the current and previous year.

7. LAY WORKER

The lay worker is an employee of the Weald of Kent Methodist Circuit. The amount charged in the Receipts and Payments Account represents reimbursement to the circuit of this cost and the expenses incurred carrying out the lay worker's duties.

8. OTHER EXPENSES

Other expenses include the cost of cleaning the church premises and general administration.

9. INVESTMENTS

The Trustees for Methodist Church Purposes are the legal owner and custodian trustees of the legacy fund investments, which are all listed on a registered Stock Exchange.

10. BANK BALANCES

Funds are held by Charities Aid Foundation (CAF) and Santander Plc on behalf of the Church.

11. CREDITORS

The Accounts are prepared on a Receipts and Payments basis which does not require the disclosure of debtors and creditors. The Statement of Assets and Liabilities includes as a note the debtors, payments in advance and the creditors at 31 August 2024. The Trustees confirm that apart from the items shown the Church has no significant short or long term liabilities at 31 August 2024.

12. CAPITAL COMMITMENTS AND CONTINGENT LIABILITIES

At 31 August 2024 the Church had no capital commitments and no contingent liabilities were identified.
