The Guthrum-Aethelstan Heritage Group (GAHG) currently has four trustees and a non-trustee treasurer. GAHG maintains a charity business bank account. The trustees and treasurer meet approximately monthly. GAHG maintains an email list for its newsletter and other announcements of approximately 50 people, mostly local to Hadleigh. Newsletter subscribers are those interested in Guthrum, local history, and the work of the group; they do not undertake or organise the work of the group themselves.

The Guthrum-Aethelstan Heritage Group CIO is for the advancement of education of the public in the subject of Viking history by educating the public about the life of King Guthrum and the local tradition and heritage of the link between Hadleigh Suffolk and King Guthrum. In particular but not exclusively by the provision of lectures, newsletters, exhibitions, town trails and work with local schools.

The Guthrum – Aethelstan Heritage Group was registered as a CIO (Charity No. 1206070) with the Charities Commission on 06/12/2023.

In short, the aim of the charity is to raise awareness of King Guthrum's link to Hadleigh, Suffolk. To achieve this aim, its long-term objectives include:

- developing a plan, securing a suitable site and funding for a King Guthrum memorial;
- exploring ways to engage community and raise interest and awareness of King Guthrum.

Activities in support of these objectives include:

- fundraising events;
- growing a database of people interested in supporting the charity and its work;
- organising events to raise awareness and knowledge of King Guthrum and his links to Hadleigh;
- publishing a regular newsletter.
- creating and maintaining a bibliography of resources on King Guthrum.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

**Summary of the main achievements of the charity during the year**

A Business Community Current Account was opened with Metro Bank on 13th November 2024 in the name of King Guthrum Group.

The following four Trustees were appointed on or before registration. Huw Roberts (Chair); Susan Andrews; Hilary Ferry; Kathryn Grandon.

Roger Young was appointed Treasurer on 8th January 2025.

Public liability insurance was obtained for the 12 months from August 2024.

The group publishes a quarterly newsletter, sent to those who sign up to receive it (approximately 50 people).

A fundraising exercise titled "The Old Hadleigh Picture Show" was delivered in four parts at the Ansell Centre, Hadleigh. The "The Old Hadleigh Picture Show" presentations were held in September and October 2024 and March and May 2025 and attended by approximately 800 people.

Prior to these events the organisation had no funds.

The group has produced an illustrated booklet ('In Search Of Guthrum') summarising the historical evidence for Guthrum's link to Hadleigh.

The group has also produced a leaflet outlining its work and objectives, contact details, etc.


