TO PROMOTE THE RELIEF OF PEOPLE IN NEED BY THE PROVISION OF AN ADVOCACY SERVICE WITH THE AIM OF RELIEVING THE NEEDS OF PEOPLE WHO ARE SOCIALLY EXCLUDED, OR OTHERWISE VULNERABLE, ASSISTING THEM TO INTEGRATE INTO SOCIETY AND/ OR IMPROVING THEIR CONDITIONS OF LIFE; AND4.2. TO ADVANCE EDUCATION IN PARTICULAR TRAINING IN ADVOCACY SKILLS.

**Activities:** Angel Advocates can help in most situations involving individuals or groups and an authority (an authority is usually a public service provider, i.e., local council, NHS, schools and education, courts, or other government departments, care providers). You do not need to be entitled to an advocate under the law to access Angel Advocates.
