The Trustees have pleasure in submitting the Report and Accounts for the year ended 31 December 2024.

Objects of the charity

The charity, which is a church, is governed by a Constitution and Church Handbook and is registered as a charitable incorporated organisation. The charity's principle objective, as set out in its governing documents, is the advancement of the Christian faith.
