*The promotion of social inclusion among parents and their children who have Special Educational Needs, who are excluded from society, or parts of society, due to their social and economic position by the provision of a drop in support centre, supervised arts and craft sessions, coffee mornings and parenting courses to enable SEND parents and their children to develop and gain new skills".*

During this period, our first year, SENDOURWAY has run coffee mornings together with Messy play activities for parents/caregivers who have children and young adults with additional needs. These have been run on the 2<sup>nd</sup> and 4<sup>th</sup> Tuesday mornings of each month.

During this period, we have prepared a Dads course ready to run in the future.

The charity has also run parenting courses for primary age children and arts and crafts for parents, Grandparents and caregivers who have children with additional needs.

Sendourway have produced printed leaflets to advertise who we are and what we do in the community. We have also produced welcome packs with a range of information about us and details of how to contact us, including business cards printed with the charity's website and contact details on them for easy access.

**Future Plans:**

Further Training including, a Parenting Facilitator SEND Course and Family Support Worker training.

To continue arts & crafts and to run SEND children parenting courses while continuing coffee mornings with Messy Play partnership in a Community Church setting.

Work alongside Canewdon Community Centre, to support staff and encourage them to create their own group support activities. Planning to visit groups in churches, U3A etc, to inform and promote our charity, continue to look for further funding opportunities to support existing activities and new opportunities.

**Summary of the main achievements of the charity during the year**

During this year, SENDOURWAY has successfully run a total of 19 coffee mornings, across two sites, with over half of these including Messy play activities for parents/caregivers who have children and young adults with additional needs. These have been run on the 2<sup>nd</sup> and 4<sup>th</sup> Tuesday mornings of each month.

We have helped and supported approximately 13 adults and 18 children and are expecting to help and support more people in the coming year. Other achievements include successfully presenting 1 parenting course for parents of primary age children, and an arts and craft session for parents, caregivers and Grandparents of children with additional needs. We are planning to do more Parenting courses in the coming year including a SEND parenting course.

We have achieved with careful planning a positive bank balance at the end of the year putting us in a good position to start the coming year.

The grant funding that we have been awarded has supported the charity to enable us to do specific training such as Safe Guarding, parenting, facilitator course for SEND families and Family Support Worker which has enabled us to run courses for families. Other funding has given us opportunities to run a coffee morning/messy play for parents/caregivers and Grandparents with young children who have additional needs. This has provided families to have a safe environment where they can share their concerns as well as sign posting them to the right authorities that would benefit them. We also run a craft session for the adults to give them some wellbeing time for themselves and opportunities to meet new friends.
