Summary of the main achievements of the charity during the year

Achievements and Performance

During the year, the trustees are pleased to report significant progress in advancing the charitable objects of the South Wales Community Academy. The charity continued to focus on supporting disadvantaged families, improving educational outcomes, and promoting lifelong learning within the local and wider community.

Educational Support for Disadvantaged Families

The charity delivered regular English and Mathematics sessions for children and young people from low-income and deprived households. These after-school lessons were held from 5pm to 7pm, providing a structured and supportive environment outside normal school hours. Learners benefited from small-group teaching, targeted intervention, and consistent encouragement, helping them build confidence and improve academic performance.

Advancing Education in English and Mathematics

The Academy provided GCSE-focused support aligned with the school curriculum. Pupils received help with exam preparation, revision techniques, and core subject knowledge. These sessions ensured that learners who lacked access to private tuition or additional school support could still achieve strong educational outcomes.

Lifelong Learning and Personal Development

Adults and older learners participated in sessions designed to improve literacy, numeracy, and general learning skills. These activities supported personal development, increased independence, and helped individuals re-engage with education at their own pace.

Support for Further and Higher Education

The charity offered guidance and mentoring to learners progressing to college, apprenticeships, or university. This included help with applications, personal statements, and understanding available pathways. Practical support was also provided where needed to reduce barriers to continued education.

Collaboration With Other Charities and Community Organisations

The Academy worked alongside local charities and community groups to ensure families received coordinated educational support. This included sharing resources, accepting referrals, and signposting individuals to specialist services where appropriate.

Adult Learning for Those Not in Full-Time Employment

Informal learning opportunities were provided for adults seeking to improve their English, Maths, or general skills. These sessions supported wellbeing, confidence, and employability, particularly for individuals returning to education after long periods.

Support for Refugees and Newly Arrived Families

The charity delivered targeted English language support for refugees and recently arrived families in Cardiff and the wider community. This helped learners integrate into local schools, understand community systems, and develop the independence needed to participate fully in Welsh society.

Providing a Safe and Supportive Environment

Across all activities, the Academy maintained a safe, friendly, and inclusive environment. Students were supported not only academically but also emotionally, helping them build self-esteem, resilience, and
