The Trustees present the annual report and financial statements of the Charity for the period ended 4 October 2024. The financial statements comply with current statutory requirements and the requirements of the Charity's governing document. The financial results are set out in the enclosed accounts.

Objectives and Activities

The prevention or relief of poverty in Bangladesh by providing: grants to those who meet the criteria set by the trustees for essentials such as clean water, food, clothing, shelter and access to basic education and healthcare, items and services to individuals in need and, or charities, or other organisation working to prevent or relieve poverty

Achievements and Performance

During the period, £2,960 was spent towards charitable projects which included the building of homes in Bangladesh, and supporting a football event in Bangladesh. The trustees aim to increase expenditure towards charitable projects in the forthcoming years.

Review of the financial position

The income for the period amounted to £7,498, which was entirely through donations.

Reserves

There are no unrestricted reserves.

The Charity has been setup as a charitable incorporated organisation (CIO) and is governed by a Trust deed.

Basis of independent examiner's report:
