Charity Overview

Friends of APSOL (FoAPSOL) is a Charitable Incorporated Organisation (CIO) established to support the educational and community life of the Anglo Portuguese School of London. The charity enhances the learning environment by funding initiatives, equipment, and events that benefit pupils and foster community engagement.

Activities and Achievements

In the period 1 January-31 August 2024, Friends of APSOL organised two key fundraising events. These events brought together the school community and successfully raised funds to support the charity's educational mission. Total income for the year was £5,373.56, with a net profit of £4,232.55 after event costs.
