Trustees' Report

From 9 January to 31 December 2024

The Trustees present their report and accounts for EduWell Charity for the year ended 31 December 2024.

The accounts have been prepared by the accounting policies set out in note 1 to the accounts and comply with the charity's constitution, the Charities Act 2011, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts by the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

Structure, Governance and Management

EduWell Charity is a Charitable Incorporated Organisation (CIO), dedicated to the advancement of education. Having served the community for over seven years, the charity operates under its "Education Divisions" framework, underpinned by an integrated administrative body.

The day-to-day management and execution of projects are overseen by a dedicated executive unit associated with the Selly Oak Arabic School (SOAS), which draws upon active membership within the Birmingham community. This compact yet dynamic SOAS team implements transformative projects through effective administration, skilled coordination, and a commitment to robust methodologies.

Trustees are appointed by the charity's constitution. New trustees are inducted into the workings of the charity, including their legal obligations, the content of the governing document, and recent financial performance.

Objectives and Activities

The primary objective of EduWell Charity is to advance education for the public benefit. We believe that education and well-being are fundamental rights for every child and every woman. Our work aims to enhance creativity and productivity, raise awareness of mental health, and increase opportunities for individuals to live with dignity.

The charity undertakes numerous successful projects, both seasonal and ongoing, made possible through the unwavering support of generous philanthropists from our vibrant UK Birmingham community.

Achievements and Performance: A Review of Activities
