
The Charity is a CIO and is governed by a constitution dated 23 July 2023; apart from the Rector, who is ex-officio, 8 trustees are appointed by the parish councils of Bedale, Aiskew with Leeming and Crakehall and 16 are elected.

The objects of the charity are: To relieve either generally or individually persons resident in the area of the parishes of Aiskew and Leeming Bar, Bedale, Burrill with Cowling, Crakehall, Firby, Langthorne and Rand Grange who are in conditions of need, hardship or distress by making grants of money or providing or paying for items, services or facilities calculated to reduce the need, hardship or distress of such persons.

The CIO spent the 15 months since Charity Commission approval waiting for the activities and assets of the 'old' charities (224035 and 529517) to be transferred to the CIO. By the end of March 2025, the first cash transfer had completed.
