Activities: To advance the religion of Christian Science for the benefit of the public by promoting pupils' "progress in the understanding of divine Principle... that they prove sound in sentiment and practical in Christian Science." (Manual of The Mother Church, Art. XXVI, Sect 2), enabling them to follow Christ's example and become better healers to the benefit of all mankind.

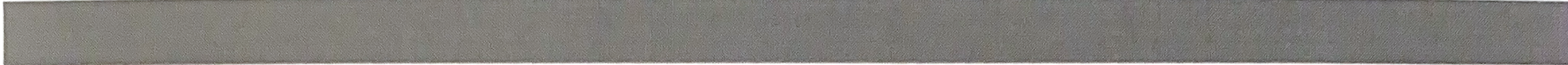
