A class for Parkinson's Disease sufferers, in conjunction with North Devon District Hospital. All members have seen an improvement in their motor skills and overall fitness in a relatively short period of time. The oldest member of this class is 81. 2. Working with Devon & Cornwall Police, working with and training local young offenders. The re-offending rate for the young people involved has been zero. No charge is made for this work by the Club. It is purely for the benefit of the local community. 3. Working with a satellite class of young people from Pilton College who struggle with their confidence.






