REPORT OF THE TRUSTEES **FOR THE PERIOD 9 FEBRUARY 2024 TO 31 DECEMBER 2024**

The trustees present their report with the financial statements of the charity for the period 9 February 2024 to 31 December 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and public benefits

The Foundation's charitable purposes, as set out in its constitution, are:

1. Advancement of Religion:

To advance the religion of Islam in Greenwich and surrounding areas through prayer meetings, lectures, celebrations of religious festivals, and the production or distribution of educational materials to promote understanding of Islam.

2. Relief of Poverty and Financial Hardship:

To assist individuals and families in need by providing emergency food parcels, welfare support, and guidance on accessing local advisory services.

3. Advancement of Education:

To advance education in subjects including Arabic, English, Mathematics, Science, and Islamic Studies. This is achieved through weekend supplementary classes for children and adult learning programmes.

Public Benefit Statement:

The Foundation ensures public benefit by:

Offering affordable fees and discounted or free places for families in financial difficulty.

Guaranteeing open access for all local children, regardless of faith, background, or ability.

Operating in a manner consistent with the Charities Act 2011 and the Charity Commission's guidance on public benefit.

Volunteers

The charity benefits from a small group of highly skilled and motivated volunteers and are hugely important.

It is in the belief of the Trustees that volunteers contributed immensely to functioning of Charity through teaching, administration, and community events, reflecting strong local engagement and commitment.

It is our ethos to have the highest standards of care, everyone at the Charity is working towards this.

The Trustees wish to thank all those volunteers who have given and who continue to give their time so willingly.

Volunteers are vital to the delivery of our services and without their help, the Charity would be at a huge disadvantage.

ACHIEVEMENT AND PERFORMANCE

Achievements and charitable activities

During the reporting period, the Foundation achieved significant growth and progress across its educational and community programmes:

Weekend School: Conducted weekly Saturday morning classes in Qur'anic Reading, Arabic Language, Islamic Studies, and Moral Education.

Enrolment Growth: Increased student enrolment from 40 to 60 in 2024, with an average attendance rate of 85%.

Community Engagement: Organised a subsidised Annual Mosque Visit and Eid Celebration.

Positive Outcomes: 95% of parents expressed feedback that their children's behaviour, confidence, and understanding of religion improved.

Digital Education Initiative: Launched an online learning platform offering over 800 free small-group lessons during the year, to fast-track children progress and improving accessibility for students unable to attend in person.

Challenges and Mitigation:

Limited Classroom Space: Addressed by renting additional classroom to meet growing demands.

Volunteer Turnover: Targeted local volunteer recruitment to support students enrolled in Duke of Edinburgh volunteer programmes.

Fluctuating Donations: Initiated community fundraising events and diversified income streams through regular food.

Financial position

The Charity maintains a sound financial position with effective controls and transparent reporting procedures

FUTURE PLANS

The Foundation's strategic priorities for the coming year include:

Enhanced Teacher Training: Provide continuous professional development to tutors.

Expanded Academic Support: Offer subsidised Mathematics, Science, and English lessons for families receiving Universal Credit.

Parental Engagement: Deliver Parenting Skills Workshops to strengthen family involvement in education.

The Trustees believe, these initiatives will further strengthen the Foundation's educational impact and community outreach.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The organisation is a Charitable Incorporated Organisation (CIO) - Foundation Model, registered with the Charity Commission on 9 February 2024.

Trustee recruitment and training

Trustees are appointed through a combination of internal networks and community advertising. Upon appointment, each trustee receives induction training covering charity governance, financial responsibilities, and safeguarding.

Organisational structure

The Charity is overseen by its Trustees, who actively volunteer in all Charity projects and meet quarterly to review operations, ensuring compliance, and setting strategic priorities.



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the Statement of Financial Activities on a straight line basis over the period of the lease.
