In 2024, we performed in Disneyland Paris.

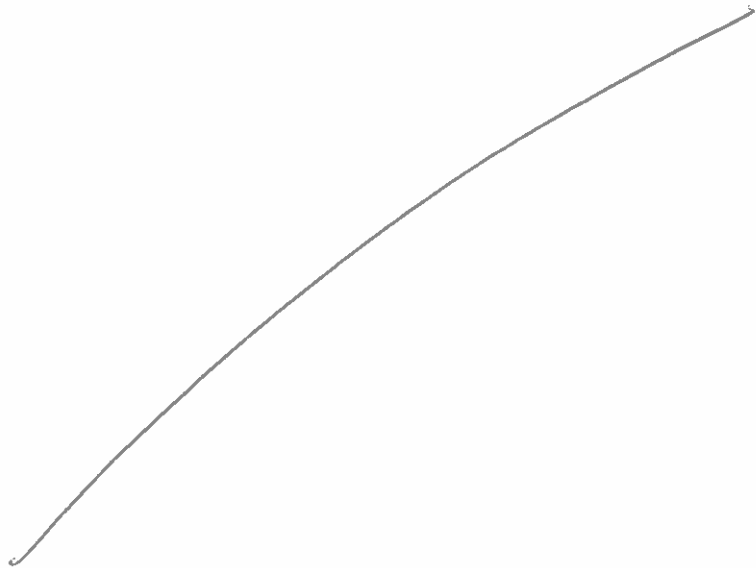
We also performed into The Woody and a concert on 42nd Street.

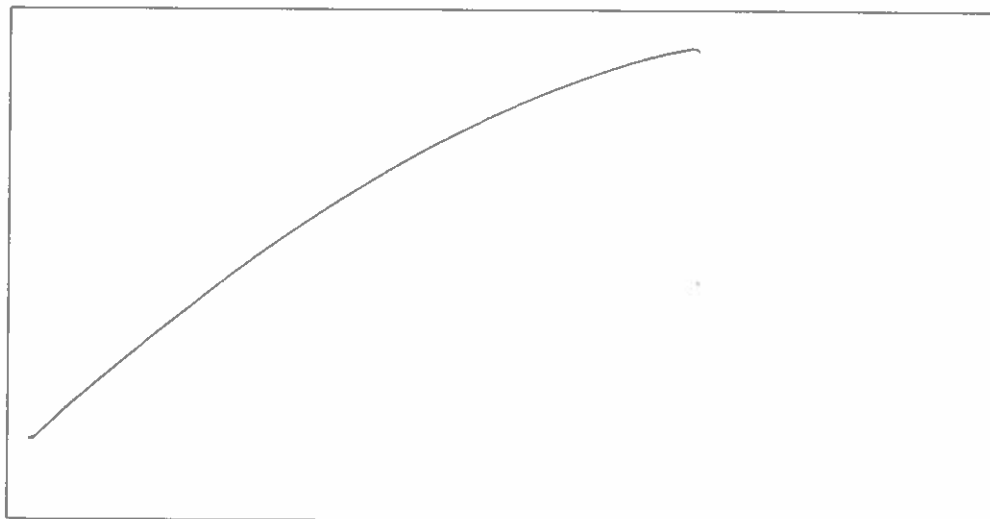

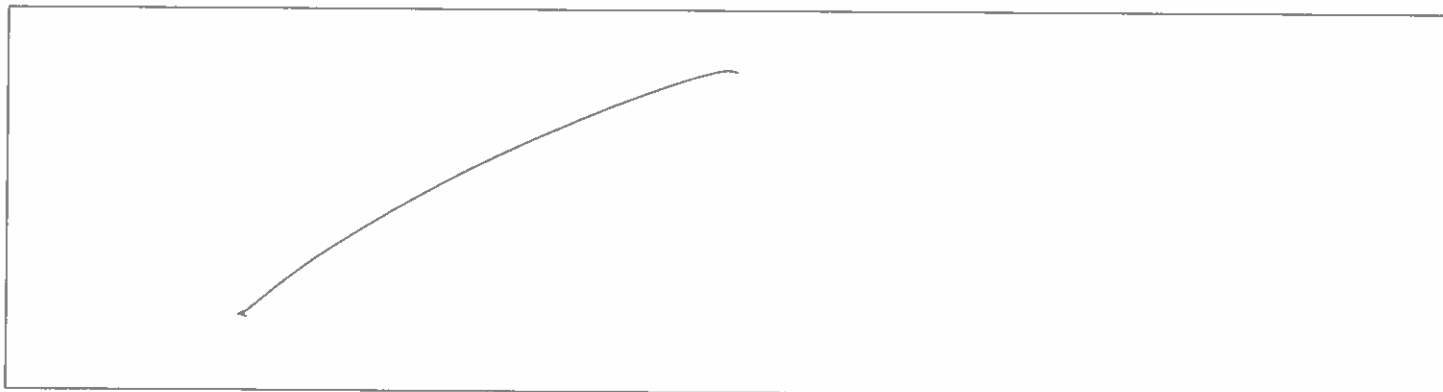


