## Financial Review

<p>Review of the charity's financial position at the end of the period</p>	<p>Para 1.21</p>	<p>For this reporting period, the charity managed its liquidity using its core merchant processing channel (PayPal) and a dedicated bank account (Chase) opened specifically to administer a major student Study Visit program.</p> <p>The charity holds a stable, unencumbered financial position with total consolidated liquid reserves of <b>£5,692.38</b>. All program-specific income from the Study Visit project was fully deployed, and the supporting bank channel was successfully wound down and closed at a £0.00 balance, centralising all remaining organization capital within the primary PayPal account.</p> <p><b>2024–2025 baseline:</b> The charity began the cycle with £3,312.38. General e-commerce activity (individual memberships and project participation fees) generated £5,686.00 in sales during 2024, though a high volume of subsequent programmatic purchases (£6,592.64) and necessary operational withdrawals (£1,940.20) temporarily reduced the balance to a low of £515.62 in August 2025.</p> <p><b>Recovery and final expansion:</b> Funds were systematically rebuilt in Autumn 2025 via bank deposits (individual memberships and project participation fees) totalling £5,162.00. In early 2026, the account experienced stable revenue expansion, gathering £1,110.00 in checkout payments. Standard operational outlays were restricted to platform maintenance infrastructure, including localised web services (Squarespace payments totalling €367.20).</p> <p>The Trustees report that the charity remains entirely free of debt or payables liabilities. All self-funded components of the major student Study Visit program have been completely delivered and settled. The consolidated unrestricted reserve of £5,692.38 is deemed fully sufficient to maintain operational continuity and insulate upcoming educational initiatives over the next 12 months.</p>
<p>Statement explaining the policy for holding reserves stating why they are held</p>	<p>Para 1.22</p>	<p>The organisation does not actively maintain or hold restricted reserve balances within its primary transactional accounts.</p> <p>All funds processed and maintained through the organisation's PayPal merchant account are classified as fully unrestricted and available balances. Because there are no merchant-imposed or internally set aside reserve funds, a traditional policy explaining why reserves</p>

		<p>are held is not applicable to the current account structures.</p> <p>As verified by the financial statements, ELSA UK operates entirely out of its liquid, available balances and carries zero reserve restrictions across its reporting platforms.</p>
