STRUCTURE GOVERNANCE AND MANAGEMENT

Serendipity Arts UK is a registered charity constituted as a Charitable Incorporated Organisation and registered with the Charity Commission on 16 February 2024.

OBJECTIVES AND ACTIVITIES

The charity's objects are:

"To advance the arts, culture, heritage and science and to further the education of the public in the appreciation of the foregoing particularly, but not exclusively, by:

supporting through grant making multi-disciplinary cultural and artistic projects, exhibitions and museums in the South Asian region in such ways and in such manner as shall be exclusively charitable; and

facilitating access and inclusivity to the arts and science for all, including but not limited to those who are disadvantaged by financial hardship or are living with physical or mental disability.

To advance such other charitable purposes as the trustees of the charity may in their absolute discretion determine from time to time"

ACHIEVEMENTS, PERFORMANCE AND FINANCIAL REVIEW

Total income for the year amounted to £698 and compromised income arising on the charity's funds.

Charitable expenditure in the year comprised legal and administration fees and governance costs totaling £42,557.

PLANS FOR FUTURE PERIODS

The trustees intend to make grants to further the charity's objects.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The trustees are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).
