Objects: 3.1 TO PROMOTE SOCIAL INCLUSION FOR THE PUBLIC BENEFIT BY WORKING WITH PEOPLE IN THE VICINITY OF SOUTHEND-ON-SEA WHO ARE SOCIALLY EXCLUDED ON THE GROUNDS OF THEIR ETHNIC ORIGIN, RELIGION, BELIEF OR CREED (IN PARTICULAR, MEMBERS OF THE TAMIL COMMUNITY) TO RELIEVE THE NEEDS OF SUCH PEOPLE AND ASSIST THEM TO INTEGRATE INTO SOCIETY, IN PARTICULAR BY: A) PROVIDING A LOCAL NETWORK GROUP THAT ENCOURAGES AND ENABLES MEMBERS OF THE TAMIL COMMUNITY TO PARTICIPATE MORE EFFECTIVELY WITH THE WIDER COMMUNITY; B) INCREASING, OR CO-ORDINATING, OPPORTUNITIES FOR MEMBERS OF THE TAMIL COMMUNITY TO ENGAGE WITH SERVICE PROVIDERS, TO ENABLE THOSE PROVIDERS TO ADAPT SERVICES TO BETTER MEET THE NEEDS OF THAT COMMUNITY. Objects

The charity's objects are:

3.1 To promote social inclusion for the public benefit by working with people in the vicinity of Southend-on-Sea who are socially excluded on the grounds of their ethnic origin, religion, belief or creed (in particular, members of the Tamil community) to relieve the needs of such people and

assist them to integrate into society, in particular by:

- a) providing a local network group that encourages and enables members of the Tamil community to participate more effectively with the wider community;
- b) increasing, or co-ordinating, opportunities for members of the Tamil community to engage with service providers, to enable those providers to adapt services to better meet the needs of that community.
- c) providing recreational and leisure time activity in the interests of social welfare for people living in the area of benefit who have need by reason of their youth, age, infirmity or disability, poverty or social and economic circumstances with a view to improving the conditions of life of such persons.

3.2 To advance the education of the public in Tamil culture and heritage, including assistance to children with homework support and English language and other associated educational needs in such ways as the trustees may determine.

3.3 The prevention of relief of poverty in Sri Lanka primarily by providing or assisting in the provision of education, training and all the necessary support designed to enable individuals to generate a sustainable income and be self-sufficient.

- **Public benefit**

The trustees confirm that they have complied with their duty under the Charities Act 2011 to have due regard to public benefit guidance issued by the Charity Commission.

During the year, the charity carried out the following main activities to further its charitable purposes:

- Annual Sports Day on Saturday 6th of July 2024 between 10am – 5pm at Hamstel Junior School, Hamstel Road, Southend-on-Sea, SS2 4PQ
- September 2024 started to build a community center and shops for war affected local community benefit in Manikkamadu, irakkamam, Ampara, Sri Lanka.
- Various small projects have been undertaken to improve the life of the war affected women headed single parents families.

1 ACCOUNTING POLICIES

The Financial Statements have been prepared in accordance with applicable accounting standards.

(a) Accounting Convention

The Financial Statements are prepared under the historical cost convention.

(b) Donations

Donations are accounted for when received and banked.

(c) Expenditure

(d) Restricted and unrestricted funds
