Report of the Trustees for the year ended 31 December 2024

Structure, Governance and Management

Kane Mental Health CIO is a Charitable Incorporated Organisation (CIO), governed by its constitution adopted in 2023. The charity is managed by its trustees — Zoe Nicholas, Nicole McLean, and Nicola Edwards — who are responsible for ensuring compliance with the governing document, charity law, and the effective management of the charity's affairs. The trustees collectively oversee strategic direction, financial management, and operational planning. The charity did not employ any paid staff during 2024. The trustees intend to expand the charity's governance structure and volunteer base as its activities develop.

Objectives and Activities

The charitable objective of Kane Mental Health CIO is: "To promote positive mental health and wellbeing for individuals and communities by providing accessible support, counselling, and information services." Kane Mental Health CIO aims to provide both telephone and face-to-face counselling, as well as telephone and internet helplines offering advice, support, and signposting to appropriate services. The charity's office will operate Monday to Friday, 9am–5pm, with helplines manned until 8pm. Initially, the organisation will be supported by trained volunteers with relevant professional certifications and experience in mental health support. All services are to be provided free of charge to ensure accessibility to anyone in need. The charity's approach includes early intervention for individuals aged 18–40, signposting to professional services, promoting healthy lifestyle choices, and delivering free community-based courses such as nature walks and holistic therapies. Promotion of services will include collaboration with GPs, NHS teams, schools, police, and community organisations.

Achievements and Performance

During 2024, the trustees focused on establishing the charity's administrative and operational foundation. Key achievements included: - Completion of registration as a Charitable Incorporated Organisation with the Charity Commission. - Development of policies and procedures to ensure compliance with legal, financial, and safeguarding standards. - Research into suitable office locations within the Barnet, Hertfordshire area. - Creation of an operational framework for counselling and helpline services to be implemented in 2025. No service delivery took place during 2024, as the focus remained on building a robust foundation for safe and sustainable operations.

Financial Review

During the year, Kane Mental Health CIO had no income and total expenditure of £4,799.73, relating primarily to initial setup and administrative costs. The charity did not hold any reserves at the year end. The trustees are committed to ensuring the long-term financial sustainability of the organisation through future grant applications, community fundraising, and partnerships with local

health and community services.

Plans for the Future

In 2025, Kane Mental Health CIO intends to: - Launch its telephone and face-to-face counselling and helpline services. - Recruit and train a team of qualified volunteers. - Secure sustainable funding to support office premises and operational delivery. - Establish partnerships with local NHS and community mental health providers. - Expand public awareness through outreach and digital engagement. The long-term goal is to become a recognised and trusted provider of early-stage mental health support within the Barnet and Hertfordshire community.

Trustees' Responsibilities

The trustees are responsible for preparing the annual report and financial statements in accordance with applicable law and regulations. They must ensure that proper accounting records are maintained, financial statements comply with the Charities Act 2011, and that the charity operates in accordance with its constitution and the public benefit requirements set out by the Charity Commission.
